The primary focus of youth violence and drug prevention programs, to date, have been on prevention strategies which emphasized education rather than direct intervention. The fear of dealing with high risk and gang involved youth is a possible explanation for this. However, with the current proliferation of gang and youth violence, much of it associated with the drug trade in Pierce County, the need to focus efforts towards more direct intervention is clear.

Because of a great many factors, primarily socio-economic ethnic lines, young African-american males in particular, and more recently african-american females, have visibly increased their identitification and affialitions with gangs. Of primary concern are their activities, including the participation in violence and other crimes associated with the gang lifestyle. Gang related homocides are steadily on the rise, evidencing the need to rethink previously tried strategies in favor of more direct intervention.

The urgency of addressing this need is further supported by the following :

The targeting of high risk african american youth in the Hilltop as an initial emphasis is merited by the fact that crime, despite beefed up law enforcement efforts and community mobilization, remains a problem. Drive by shootings and illegal drug activity in this community remain significantly higher than in other locations. This is also true with regard to the consequences. Typical victims of such criminal activity are frequently innocent bystanders, almost always young and of african-american heritage.

Moreover, on a per capita basis, the Hilltop has a significantly high unemployment rate, arguably one of the highest in the county. Combined with the increased rate in teenage pregnancies and the previously mentioned problems, this becomes a key concern as it feeds into the problem and the continuing cycle of poverty which feeds crime.

The need for this approach is also supportive by technology and economic considerations. Violence and crime are expensive, not only because of fiscal decisions and personal loss they force upon us, but also because of the impact they have on our very competitiveness as a nation.

In the era of shrinking tax revenues, rising health costs, emerging technologies and the global market place, we can ill afford the continued and rising expense or loss of profit potential incurred when a significant part of our population is allowed to be and remain nonproductive and problematic..

A great many criminals, many of whom are juveniles, school drops, and the perpetually unemployed, lack the skills, knowledge and or motivation to compete in this new and highly demanding, technical and global economy. Consequently, the likelihood of them finding employment, without some form of intervention is slim.

This project, in collaboration with the community, provides an opportunity to positively impact this problem. To do so, it takes into account the realization that: (1) there is no single solution; and (2) that no single entity can do it alone. Using public and grass roots resources within the community concerned, it seeks to stimulate that long needed dynamic and atmosphere of caring and support for youth.

- Establish a caring and support structure which help youth develop high expectations, autonomy and a sense of purpose and the future through mentors and community volunteers
- Train and develop youth for peer mediation and peer mentorship roles

To accomplish this, the project incorporates a series of strategies in the form of workshops. An overview and description of these workshop follow.

Project Description

Overview: This project highlights the first phase of Safe Streets' front line high risk youth intervention strategy. It incorporates a youth developmental component in the form of three performances and one personal enrichment workshop. The four workshops, which are separate and distinct entities, are in: theatre/acting; comedy; music and personal enrichment. All four workshop will run simultaenously beginning in August '93. The workshops are the initial seeds to developing youth resiliency characteristics, and greater community participation and involvement in the lives of youth. Each workshop head will be selected based upon a demonstrated desire and proven ability to mentor and work with high risk youth.

Timeline: Each workshop will begin in August '93 for a period of six weeks. Some overlap is with the resumption the fall public school schedule is anticipated. To deconflict workshops will be held after normal school hours when required. Youth who complete the workshops will be given the opportunity to enter the second phase of the project in which they will take their acquired skills on the road as performers and mentors to schools and youth in the target community. Through this process it is hoped that these youth will become the magnet which will attract other youth, and the substance which will transform the project into a program beyond its January '94 lifespan. Upon completion, each participant will receive a certificate from Safe Streets.

Awards/prizes: Friendly competition within each workshop will be encouraged and prizes awarded to youth achieving the highest score in selected categories.

Family support and reconciliation: A family reconcilaiton and support mechanism will be included and exercised at the discretion of the project directors/mentors. When warranted they will, using funds set aside in the budget for this purpose, take youth, youth participants and their families out for pizza or dinner to give them and their families the opportunity to reconnect while creating deeper appreciation and greater family /partential involvement in the project.

Recruitment Strategy. Youth for the these activities will be recruited through a variety of organizations and individuals: volunteers, community activitists, community block organizations, youth groups, youth in the Safe Streets B.L.I.N.D. Program, Boys and Girls Clubs, the Hilltop Action Coalition, the YMCA, churches, the Tacoma Urban League, Metropolitan Parks, community centers, businesses and schools. Safe Streets will print flyers highlighting the project and distributed to these groups for dissemination. In addition, Safe Streets, through its community organizers and the individual workshop directors, will engage in direct recruitment and verbal appeal during visits to these groups.

Evaluation Plan. To ensure ongoing project implementation and success, Safe Streets will meet weekly with each contractor to determine the status of the project and or required assistance /corrective action. Anecdotal information will be collected. A comparative analysis of of the incidence of crimes committed by youth before and over the life of the project will be conducted. This analysis will also identify external factors that may have impacted the success of the project.
