I do not believe that we can spend ourselves rich with huge interest rates on bonds, over a long period of amortization.

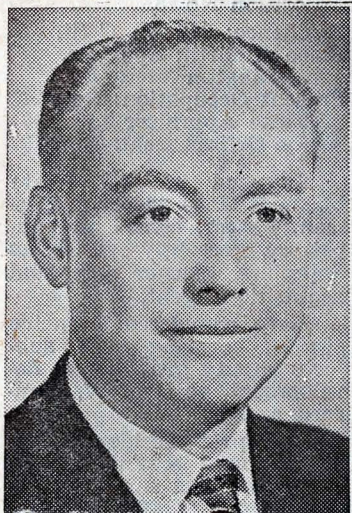
I believe our rights as citizens and taxpayers have been taken from us through political manipulation and that these rights should be returned to us.

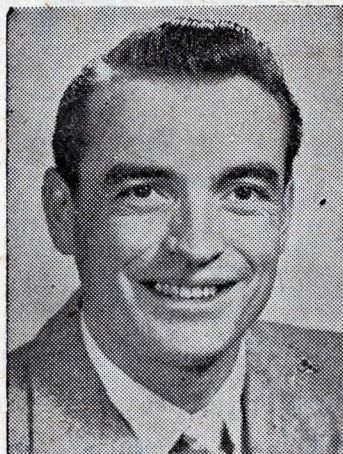
Tacoma is entering an era of great industrial and economic growth. In order to prepare for and encourage this growth we need
