CITY COUNCIL MINUTES

City Council Chambers, 4:00 P. M. Tuesday, July 12, 1966

Council met in regular session. Present on roll call 6: Bott, Finnigan, Herrmann, Johnson, Price and Mayor Tollefson. Absent 3: Cvitanich, Haley and Murtland. Mr. Cvitanich and Mr. Murtland coming in at 4:15 P.M. Mr. Haley coming in at 4:20 P.M.

Mr. Johnson moved that the minutes of the meeting of June 28, 1966 be approved as submitted. Seconded by Dr. Herrmann. Voice vote taken. Motion carried.

HEARINGS & APPEALS:

This is the date set for hearing on the appeal filed by <u>Donald F. Herron</u>, attorney for James Lee Gray on the denial of the request for rezoning of the property located at the S. W. corner of So. 66th & Cheyenna St. from an "R-2" to a "C-1" District.

Mr. Donald F. Herron, attorney, explained that his client was appealing from the Planning Commission's denial of "C-1" zoning. He added, he felt that the Commission's recommendation that this area be rezoned an "R-2-T" Single-Family Residential-Commercial Transitional would be more compatible than the present zoning. The reason for the request for rezoning is for his client to continue the business he has operated at the present location since 1956 with the presently existing structures. The "R-2-T" zoning would not permit him to retain his sign, as presently located. Mr. Herron felt that there would not be any further residential building along this street.

Mr. Murtland asked what Mr. Gray's plans were, as the "C-1" zoning would allow many other types of businesses.

Mr. Herron explained that Mr. Gray plans in the future, to expand his building, which would be allowed under the "R-2-T" zoning. However, he feels that his sign is essential to the continuation of his business and it is only permitted under a "C-1" zone.

Mr. Finnigan asked if there were some way the sign could be allowed.

Mr. Johnson suggested that the "R-2-T" District be approved and for the Board of Adjustment to make a decision as to whether the sign can be allowed.

After further discussion, Dr. Herrmann moved to concur in the recommendation of the Planning Commission to deny the "C-1" rezoning and to approve the rezoning of this property from an "R-2" District to an "R-2-T" District. Seconded by Mr. Haley. Voice vote taken. Motion carried.

Mr. Finnigan asked if the City had any previous experience with Chaffee-Zumwalt & Associates.

Mr. Schuster, Public Works Director, explained, the Public Works Dept. has not had any work done by this company, however, the Civic Arts Commission recommended this firm and said they were the only firm that does this type of work in Tacors. He said he has a partial list of projects that Chaffee Zumwalt & Assoc. have worked on, such as the Broadway Terrace, Tacoma Elk's Lodge, Mountain View Memorial Park, and others.

Mr. Murtland asked if there were any requirement that this should be put out on a competitive bid,

Mr. McCormick, City Attorney, explained, that this was a specialized service for which bids were not necessary.

Mr. Schuster explained, this firm was being retained to design the landscaping and also to supervise portions of the work.

Ordinance No. 18093

Authorizing the condemnation of property in the area of So. Sprague between approximately So. 24th & So. 15th Sts., for a public highway and related purposes.

Mr. Schuster, Public Works Director, explained this property was to be used in connection with the Sprague Ave. improvement, in conjunction with the overpass over Nalley Valley. The widening of Sprague Ave. would leave some of the houses so close to the front property line that it would be more economical to take all of this property.

Mr. Finnigan asked if the property owners would be allowed to stay if they wished.

Mr. Schuster replied, the City can only take the property necessary for street purposes and it would be up to the property owner if he wished to stay.

REPORT:

Presentation of Classification & Pay Plan submitted by Public Administration Service.

Numerous representatives of the various Departments were present.

Mr. Charles Fiss, representative of Public Administration Service, who was retained by the City to conduct a survey of job classifications and salaries, explained that the survey was based primarily on salaries given for comparable occupations by private businesses in Tacoma and county and city governments in Washington

Mr. Fiss said, generally City of Tacoma salaries are in line with current practices. He recommended, on the basis of procedures followed by other governmental units in the Northwest, that Tacoma should not pay extra wages for longevity or a shift differential. The City of Tacoma is equal to or better than comparable public and private organizations in the area of fringe benefits.
