CITY COUNCIL MINUTES

City Council Chambers, 4:00 P. M. Tuesday, May 17. 1966

Council met in regular session. Present on roll call 7: Bott, Cvitanich, Finnigan, Herrmann, Johnson, Murtland and Mrs. Price. Absent 2: Mayor Tollefson and Mr. Haley.

In the absence of Mayor Tollefon, Deputy Mayor Herrmann presided.

Deputy Mayor Herrmann stated Mayor Tollefson has been detained in a Court case.

Mrs. Price moved that the minutes of the meeting of May 3, 1966 be approved as submitted. Seconded by Mr. Cvitanich. Voice vote taken. Motion carried.

Mr. Bill Davison of the Jr. Chamber of Commerce invited the Council members to attend the Jaycees annual open house on Saturday, May 21, 1966 at 9:00 A. M until 3:00 P. M., which is being held in connection with the Public Works Dept. who is observing National Public Works Week.

Deputy Mayor Herrmann thanked Mr. Davis and hoped a number of Council members would attend.

Presentation of Awards:

Mr. Rowlands explained that this week is police appreciation week and awards will be given to citizens, this year, for outstanding bravery and cooperation with the law.

Chief Zittel presented four outstanding Citizen Awards to Carl R. Swenson, David D. Ebert, Sheilah Ann Steele and Elzine L. Heinz who administered first aid to a Seattle Police officer, Charles J. Marshall, and probably were responsible for saving his life and the lives of his wife and children.

Awards also were presented to five other persons who assisted the Tacoma police in apprehending criminals during the past year Frank Arcuri of Puyallup, Daniel E. Paxson of Calif., Buster P. Green, Donald Hansen and James O. Barnes of Tacoma.

The recipients were congratulated by Deputy Mayor Herrmann and members of the City Council.

Mr. Buchler, Director of Planning. explained that at the hearing of the Planning Commission it was recommended, since the applicant's plans were somewhat indefinite at this time, that the "R-4-LT" zoning be granted over the No. 124 feet of the site. This would allow for the construction of the medical clinic and additional professional offices, and that the applicant br given an opportunity to withdraw his request for a "C-1" and "R-4-L" proposed zoning over the south 102 feet of the site. As per recommendations of the Planning staff, the applicant requested withdrawal of the south 102 feet of this request, since it would not prejudice future zoning requests at the same location. Therefore, this petition is for an "R-2" to an "R-4-LT" District.

Mr. Finnigan discussed the opinion from the Attorney's office in regard to the request from the LID Committee for an opinion on speed deterrents in alleys.

Mr. McCormick, City Attorney, stated that public authorities have in no case a right to unreasonably install one unguarded danger to the public in order to prevent another danger. He felt that if someone should be injured in an automobile by reason of a speed deterrent, then the City of Tacoma could very well be held legally liable for damages.

Mr. Vito Lanza of 2122 So. "J" appeared before the Council to substantiate his protest made at the L I D hearing. He remarked, that traffic was very heavy in the alley at the present time. He felt the children that used the alley would be in jeopardy, particularly with the excessive speed of cars going through the alley.

Mrs. Lillie Folks, of 2112 So, "J", also spoke in opposition to the L I D.

Mr. Johnson asked if the one-way streets could be re-instaied to twoway streets on "J" and "K".

Mr. Finnigan suggested that a speed limit be posted in the alley between "J" and "K" Streets from So. 21st to So. 23rd, and also that the two-way streets be re-instated in this area.

Roll call was taken on the Ordinance, resulting as follows:

Mr. Rowlands stated that the Public Works staff has checked the area of So, 48th and Pacific Ave, and find that a signal light is warranted and the light will be installed as soon as possible.

Mr. Rowlands explained there have been repairs to the Old City Hall, Mr. Schuster, Director of Public Works, stated the department has obtained three informal estimates on removing the shingles from the roof, and added, there seems to be a question as to exactly what the City Council desires. Mr. Schuster asked that a meeting be held with Mr. Rowlands, City Manager, at a later date to further discuss the problem and then report to the City Council.
