Establishing the Bicentennial Pavilion Revolving Fund; authorizing the appropriation of the sum of \$26,200 from the Stadium and/or Convention Fund No. 640 for operation of the Bicentennial Pavilion, repealing Ordinance 20519 and declaring an emergency making necessary the passage of this ordinance.

Earl Mittelstaedt, Finance Director, reviewed the various items the monies will be used for.

Emily Sinclair, Accountant for the Department of Community Development, supplied additional information and answered questions of Council.

The Ordinance was set over for final reading next week.

Ordinance No. 20589

Amending Chapter 13.06 of the Official Code to reclassify the westerly side of Sprague Avenue approximately 450 feet south of South 66th Street and 130 feet west of Sprague Avenue from an "R-2", "C-F-P", "C-P-N", "R-4-LT" and "R-5-PRD" to an "R-4-L-PRD" District. (Hillcrest Properties, Inc.)

Mr. Warnick excused himself from sitting in on the discussion and left the Council Chambers.

Robert Backstein, Hearings Examiner, reviewed the rezone and recommended it be approved with the restrictions he had suggested placing on the property.

The Ordinance was set over for final reading to a date to be determined.
