A letter from the Chamber of Commerce, signed by Paul Martin, Chairman of the Power Sub-Committee, was distributed to Council urging the City of Tacoma to make agreent at once of the amount of \$6,094.64 to be deducted from the 8% gross earnings tax.

Mr. Bratrud said he felt the Chamber of Commerce should have obtained all the facts before writing such a letter and also remarked about an article that appeared in the News Tribune by the Municipal League in reference to this tax. He felt before any recognized body makes a statement of this nature that they should hear the Council's side. He said perhaps there are groups that feel the Council is not right on their decision up to date, but at least before any recognized body makes any criticism they should hear the other side of the matter. He said he himself, resents this attitude taken before both sides of the matter are heard.

Mr. Anderson said he was of the same opinion as Mr. Bratrud. He felt this was an interdepartmental discussion and these groups have no right to participate in this discussion whatsoever.

Mr. Paul Martin, representing the Power Committee of the Industrial Branch of the Chamber of Commerce, said their main concern was that this \$6,000 be paid for the good of Tacoma; and with the facts at hand they had given their opinion as to how this should be done. So far, he said, its been difficult to obtain the Council's side of the story.

Mr. Rowlands said, as an ex-officio member of the Chamber of Commerce Board, he was sure if this matter had been discussed before the Board, the position of the General Government would have been explained. To his knowledge this had not been done and he felt that something of this importance should have been discussed before the Chamber Board.

Mr. Bratrud said the Council was not asked for their opinion and he felt this should be done before such an article or such a letter was written.

Dr. Humiston said it is agreed by all parties that this payment should be made; and it is also true that over a period of years, the gross earnings tax has been defined as the actual gross income of the Light Division, but periodically the Council has reviewed with the Utility Board certain items as to whether they should or should not be deducted from the gross earnings tax for purposes of payment to the City. His own personal feeling was that since there was no disagreement as to whether this should be paid or not, that this Ordinance should be passed forthwith and anytime when either

the Council or the Utility Board cares to reopen the question as to this or any other item that should be listed as a deduction and the tax not be paid, that the doors have never been closed to that discussion.

He said he felt there were two separate problems before them: whether the taxes should be paid or not and "from what pocket it should come." Dr. Humiston said he would be in favor of passing this Ordinance as written as there is no doubt in any ones mind that this bill should be paid; and he felt the door should be left open to taking this up with the Utility Board to see who should pay it.

Mr. Easterday said in view of the fact that Mr. Porter and Mayor Hanson were in Olympia today he felt that the Ordinance should be postponed until March 23, 1959. Mr. Easterday then moved that the Ordinance be postponed until March 23, 1959. Seconded by Mrs. Price. Moll call: Ayes 5; Nays 2, Goering and Dr. Humiston; Absent 2, Porter and Hanson.

Mr. Anderson said at the hearing on this L I D, 59.8% remonstrance had been filed against a portion of No. Adams from 21st to 22nd and No. 22nd from Adams to Washington. Also Mr. Leo Green, representing the Beebe Realty Company, asked that Meyers Street from 6th Avenue be deleted from the area and that it be improved at a later date. He said it was the recommendation of the L I D Committee that these two areas be deleted from the L I D.

Mr. Schuster, Director of Public Works, said these areas had been deleted. In addition, he said a petition was received today protesting the area on Adams Streefrom 6th to No. 9th Street, raising the remonstrance on this particular area from 41% to a 50.3%. The total remonstrance on the entire L I D is 13.7%: Mr. Schuster said originally the improvement was for Adams from No. 7th to No. 9th; then the Department included Adams from 6th to No. 7th for two reasons - one is the drainage from this area comes down to 6th Avenue which necessitated the installation of storm drains; secondly if this block were not paved there would be one block unpaved to Sixth Avenue.

The Ordinance was then voted upon.

A communication from Joe M. and Kathryn K. Walston protesting the rezoning property along 6th Avenue for the construction of a sanitorium for the Treatment Alcoholic Addiction.

Mr. Rowlands said that this matter will be heard by the members of the Planning Commission, Tuesday, March 17, 1959; and the rules governing the decision on a medial permit such as this state that this decision is final - no appeal can be made ther than through the Courts.

Dr. Humiston asked if this has been settled by the Planning Commission yet.

Mr. Russ Buehler, Planning Department Director, said there was one hearing on this matter and at that time the recommendation was to deny the permit. Then at the next meeting of the Board, one of the members voted to reconsider the vote. Farch 17 was set as the date for reconsideration.

Dr. Humiston explained to Mr. Walston that as matters stood the City Council has no jurisdiction over a special permit.

Mr. Joe Walston said he felt that the rules governing this subject needed investigation. According to these rules, a person applying to the Planning Commission

for a special permit may aske the Commission to reconsider their action but the people involved in the neighborhood cannot. He said it seemed to him that this one point in the Charter was lacking and that the rules should be amended to correct the situation.

Dr. Humiston said he felt that this should be looked into and asked Mr. Rowlands to prepare a brief on this problem for the Council's information.

Mr. Rowlands informed the Council of the Tacoma Athletic Commission Banque Thursday, March 19, 1959 in honor of the Stadium High School and P. L. C. basket ball teams at the T. A. C.

Mr. Rowlands distributed memos concerning parking at the County-City Building. He said identification stickers would be provided for the cars to be parked in the lot.

Mr. Rowlands said there had been a number of inquiries about the disposition of the City Hall. He passed out a communication from Mr. Schuster, Director of Publiworks, which summarized the situation. It stated that the present building code would permit a type of construction with a maximum height of two stories only. Inam as the building suffered extensive damage during the 1949 earthquake, it was doubtfut if the tower structure would withstand another shock. The rodent and termite infestation has continued despite the employment of an exterminator. The remodeling of the building would cost somewhere around \$500,000 and would still not overcome the obsolecent factors. The communication stated that estimates were obtained from demolition contractors concerning the demolition of the City Hall, the north garage, the Old Public Safety Building and garages, and it was the opinion that a call for bids would produce a cost of \$40,000 to \$50,000 for this project.

Mrs. Goering asked what would become of the chimes and the clock.

Mr. Rowlands said school officials were considering the possibility of installing the chimes in the bell tower planned for the new South Tacoma High School Also the Historical Society is interested in part of the old clock mechanism for historical reasons.

Mr. Rowlands said if the Council will recall, about a year or year and a

half ago a survey was made by Mr. Blangy, an appraiser, to determine the going rate for City rental property, particularly in the Dock Street area. He wanted to alert the Council to the fact that they have had some discussion with the Tacoma Boiler Works who are renting property from the City. According to the appraisers the going monthly rate should be around \$88.00 a month. Mr. Davis of the Tacoma Boiler Works feels that the present rate of \$45.00 a month is sufficient. The City intends to serve notice on Mr. Davis in accordance with the going monthly rate of \$88 a month.

Hrs. Price invited the Council members to attend the Tacoma Youth Council Banquet, Tuesday evening, March 17, at Wells Hall. She said the banquets were very worthwhile.

There being no further business to come before the meeting, upon motion duly made and seconded, the meeting was adjourned at 5:10 P.M.
