Before the passage of this ordinance there should be an understanding as to just what property the State will need for the Freeway, as changing to a C-2 will increase the valuation and also the amount the State will have to pay, should it require this tract of land, Mr. Rowlands stated. The ordinance was then placed in order of final reading.

### Ordinance No. 15833:

Ordering the construction, reconstruction and repair of sidewalks gutters and curbs along and driveways across sidewalks; providing for payment therefor; stating the amounts of cost to be borne by the Sidewalk Construction Fund (W.Q. 7707). Read by title. Mr. Rowlands called upon Public Works Director Staman for a report on the controversial issues which were brought out at the hearing last Monday night. Mr. Staman reported that a number of the property owners on Huson Drive had been contacted and the rest will be before the sidewalks are installed. If a property dwner does not want the sidewalk, they will not be installed, he added. They have eliminated the sidewalks on one side of Prospect Street, where the property owners had objected, Mr. Staman said. The Public Works Department is endeavoring to improve the drainage situation on East B Street before the sidewalks are reconstructed, Mr. Staman reported. The ordinance was then placed in order of final reading.

Moved by Mr. Tollefson that the above report (listed on the Agenda under "Unfinished Business") be laid over for one week to March 18, 1957. ### COMMENTS BY THE CITY MANAGER:

Mr. Rowlands reported that the Preliminary Report from Brown and Caldwell on the Sewer Survey has been distributed to Council Members. The final report will be ready in about six weeks, he added.

Mr. Rowlands called attention to a letter from the Metropolitan Park District, relative to "L I D Development adjacent to Park District properties" which had been furnished each Council member with the agenda. He felt the problems enumerated can be worked out successfully with the Park Board officials. Mr. Rowlands stated.

Mr. Rowlands commended City Engineer Myron Calkins, and Robert G. Anderson of the Public Works Staff for the excellent job they had done in the Construction Standardization Report of the American Public Works Association, copies of which had been furnished Council membess. This report is for the purpose of standardization of curbs, gutters, walks etc., in various Washington Cities.

Mayor Anderson announced that the meeting would be open to the public at this time for discussion of problems pertaining to the City government and City Charter amendments, and asked if anyone wished to speak.

Mr. Joseph Fendrick, 3507 South L Street, said he would like to talk to Council about parking. The city government is abusing parking by occupying four or five spaces 24 hours a day in front of the Youth Center at 711 Commerce Street, while just below this Building the Police Garage is often empty. Mr. Rowlands advised, that Traffic Engineer Kosai, is now making a survey of parking in the downtown area, which will possibly make available to the public a few additional parking spaces. The report of this survey will be ready in a week or two, he added.

Mr. John C. Fry, 2609 North 8th Street, referred to a newspaper article relative to a statement by Dr. Battin at last week's meeting stating that the Teamsters Union had threatened him. Mr. Fry defended the Teamsters Union and said he felt this statement should be retracted as it did not help the Council and in fact was detrimental.

a quote, but inferred the Teameters Union, which was behind the last Charter move, was also responsible for the threats, and the article was the responsibility of the reporter.

Albert H. Hooker, former Councilman, spoke in favor of the City-Manager form of government. At one time he had been in favor of certain changes, but has since come to the conclusion that any change in the present charter will tend to weaken the Council-Manager government, Mr. Hooker stated. He stressed the point that all members of the Council were equally important, with the Mayor assuming the roll, of official representative of the City of Tacoma. He suggested that the Mayor delegate some of his official duties to other members of the Council who were elected to serve with him. In conclusion Mr. Hooker urged Council to make no changes whatsoever in the existing Charter.

Mr. Otto Dunayski of 1016 South 8th Street, asked why the cost of city government had increased so much under the City Manager form of government, pointing out that in 1955 the budget was \$26,000,000. while in 1957 it reached a high of \$46,000,000. He claimed taxation is increasing to the point where the laboring classes can no longer assume the bill. Dr. Humiston explained that \$15,000,000 had been included in the budget for construction of the Cowlitz Project, and this amount did not represent an increase in taxes as it was to be derived from a revenue bond issue.

Mr. Rowlands pointed out that the 40 mill tax limitiss in effect

under State Law, and that the major increase in the tax bill in Tacoma is due to the school millage and the 9 mills for Park improvement, which were voted by the citizens.

Mr. Dunayski said he felt the money which was being collected as a sewer tax should be used for the purpose it was intended, namely sewage treatment plants. The 1957 Budget shows that the cost of operating the present plant is \$105,000 while the income from this tax in 1956 amounted to \$300,000 and this has been going on for 6 years so a substantial surplus should exist, Mr. Dunayski added.

Mr. Rowlands stated that Brown and Caldwell have suggested an increase in the sewer tax to pay for needed sanitary sewers, trunk sewers, storm sewers and treatment plants which they extimate will cost between twenty-eight and thirty million dollars.

Mr. John C. Fry spoke again and asked if it would be possible for the City Council to pass an ordinance to levy a tax of \$10 or \$12 per year on automobiles using the City Streets. This is being done in Kansas City, Mo., and funds are used for City Streets and boulevards, thus relieving the tax payer of a heavy burden, he added. City Attorney Marshall McCormick advised that the City could only levy taxes permitted by State Law and this was not one of them. The only way such a tax could be levied would be to have the Legislature pass a law granting the cities this power, Mr. McCormick added. i . i

Mr. Fry outlined a unified form of government. The Council would be composed of 5 members, one each from Labor, Industry, Education, Recreation and property owners. Two from each category would be nominated, and one of these w would be elected. The Council could appoint the Civil Service Board and Utility Board and take the Fire and Police Departments out of politics, he added.

No one else expressing a desire to be heard, Mayor Anderson thanked those present for: attending and announced that the discussion would be continued at next Monday's meeting in the Utility Building Auditorium.

Upon motion, duly seconded and carried, Council then adjourned at 8:25 P. M.
