COMMUNICATIONS:

Mayor Johnston made a motion to suspend the rules to consider out of sequence a request from Metropolitan Park Commissioner, Miss Lillian Babbitt, noting that the presentation should have been placed under Communications rather than Citizen Comments. Seconded by Mr. Sonntag. Voice vote taken and carried.

Mrs. Babbitt reviewed for the Council the proposed plans of the Bicentennial Committee for art in the park, which proposes a sculpture for Point Defiance Park. The sculpture is entitled "The Family," and is a large sized bronze sculpture by Clare Shaver, a local sculptor. Mrs. Babbitt noted this is a public subscription drive and efforts to raise some \$22,000 for the statue, and solicited the Council's support and approval. She noted that the Metropolitan Park Board has approved the proposed plans and supports it wholeheartedly. Mayor Johnston thanked Mrs. Babbitt for the presentation and wished her on behalf of the Council a successful campaign.
