Ordinance No. 20570

Appropriating the sum of \$474.72, or so much thereof as may be necessary, from the General Fund, for the purpose of making final payment under a 1974 contract with the Tacoma Housing Authority under the Summer Recreation Program, and declaring an emergency making necessary the passage of this ordinance and its taking effect immediately upon publication.

Mr.Hudson moved that the Resolution be adopted. Seconded by Mrs. Egan. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 23584

Authorizing the proper officers of the City to execute a lease agreement with Henderson Motor Company d/b/a Tacoma Harley-Davidson and declaring it impractical to call for public bids.

Mr. Hudson moved that the Resolution be adopted. Seconded by Mrs. Egan. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 23585 Authorizing the proper officers of the City to file an application for certain Law & Justice funds to continue the Youth Services Volunteer Program of the Department of Human Development.

Mrs. Egan moved that the Resolution be adopted. Seconded by Mr. Warnick. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 23586

Approving the preliminary plat of Stehn's Addition located on East 75th between East "D" and East "G" and on the east side of East "D" to a point 500 feet south of East 75th and on the east side of East "F" to a point 500 feet south of East 75th.

Stan Nacarato, representing the Tacoma Athletic Commission, described a proposed multipurpose minidome stadium near Cheney Stadium, seating 15,000 to 17,000 persons. He asked for official sanction by the City Council and advised he would also seek the approval of the Pierce County Commissioners and the Park Board.
