### COMMUNICATIONS:

a. Hearings Examiner submitting report and recommendation on Shoreline Management Substantial Development Permit Application No. 141.113 to allow an additional 93 slips to Postscript Enterprises d/b/a Tyee Marina along with the construction of necessary floating log breakwater. (December 17, 1975 Foss Launch & Tug Company filed an appeal.)

Robert Backstein, Hearings Examiner, reviewed his recommendation for granting the permit.

Wedell Berg, Foss Launch & Tug Company, spoke objecting to the permit to allow the additional 93 slips to be installed as he felt it would interfere with his firm's moving of log rafts.

# REPORT BY CITY MANAGER:

Erling Mork, City Manager, asked for a motion to authorize the Director of Finance to transfer funds between departments to balance the 1975 budget. The proper ordinance would come to Council for approval when this has been arranged.

Mr. Sonntag moved to suspend the rules in order to make the motion. Seconded by Mr. Warnick. Voice vote was taken and carried.

Mr. Sonntag moved that, whereas it appears from the estimates prepared by the Director of Finance that all of the appropriations contained in the Annual Budget for the year 1975 have not been fully expended, and it appears that when all expenditures have been tabulated a surplus of appropriations will exist; and whereas certain departments operating out of the General Fund have incurred deficiencies; and whereas it appears in the best interests of the City to authorize transfers of funds between departments within the General Fund in order that valid obligations incurred in excess of appropriations may be paid, therefor

That the Director of Finance be and he is hereby authorized and directed to make appropriate transfers between various departments in the General Fund of the sums appropriated but not expended, so that as of the close of the fiscal year 1975 sufficient appropriations will be available in each and every department.

I would further move that the action of the Council in adopting this motion be hereafter ratified by the adoption of the requisite ordinances and resolutions effecting said transfers and appropriations. In no event shall any of such transfers be made unless a surplus in appropriations does in fact exist.

Seconded by Mr. Warnick. Voice vote was taken and carried.
