#### CITY COUNCIL MINUTES

City Council Chambers, 4:00 P. M. Tuesday, Sept. 22, 1964

Council met in regular session. Present on roll call 9: Bott, Critanich, Finnigan, Haley, Herrmann, Johnson, Murtland, Price and Mayor Tollefson,

Mr. Haley moved that the minutes of the meeting of Sept. 8, 1964 be approved as submitted. Seconded by Mr. Finnigan. Voice vote taken. Motion carried.

#### Presentation of Awards

Mr. Rowlands presented a \$100.00 check for a suggestion award to sixteen employees of Treatment Plant #1 for their suggestion for Improved Digester Circulation by installation of a high rate pump and two additional discharge pipes.

A check in the amount of \$25.00 was presented to Harold R. Cournau for his suggestion to install a screw-type jack on all compressors to eliminate heavy lifting when hooking trailers to trucks.

Berdeen Godwin was also presented with a \$25.00 award which resulted in a savings to the City.

The recipients were congratulated by the Mayor and members of the City Council.

## Resolution No. 18027

Authorizing the proper officers to convey property generally located 500 feet west of So. Tacoma Way at 100th St. southwest to Pierce County for road purposes.

Mr. Haley moved that the Resolution be adopted. Seconded by Mr. Murtland.

The Resolution was passed unanimously by voice vote. Ayes 9; Nays 0; Absent 0.

## Resolution No. 18028

Amending the lease agreement between the City of Tacoma and the National Exhibition Co. for park and recreational facilities for a period of five years.

Mrs. Price moved that the Resolution be adopted. Seconded by Mr. Finnigan.

Mr. Rowlands stated a communication has been received from Mr. W. D. Ryan, General Manager of the Tacoma Giants Baseball Club, agent for the National Exhibition Company, lessee, for Cheney Stadium, dated Sept. 11, 1964 which stated in part that because of the uncertainty presently existing with reference to the establishment of a major league baseball club in the Pacific Northwest, the National Exhibition Co. will not enter into an agreement for a period longer than one year at this time, and if the situation has become stabalized at this time next year, and the Giants baseball Club can be assured that there will not be a major league baseball club in the Northwest, they will then discuss the possibility of negotiations of a lease for a longer period of time. Mr. Ryan assured the Council that at the present time the National Exhibition Co. does not intend to move the Tacoma Giants Baseball Club unless major league baseball comes to the northwest area.

Mr. Rowlands stated, in the event major league baseball does come to Seattle, this would permit the Giants to withdraw on nine days notice from having a team here next year. He said they have tried to point out to them that a five year lease would be better than a one year lease. Mr. Rowlands said it would be necessary to change the Resolution to read, one year instead of five years in the event the Council wants this change.

Dr. Herrmann asked if the City and County realizes their investment in the event the baseball league withdraws. He thought this showed a lack of good faith on the part of the Giants Baseball League. He said he was opposed

to changing the contract to one year and would be in favor of the contract remaining as drafted, for a five year period. He said if the Baseball League will not sign a five year contract, then he thought they should see what damages the City and County could obtain for the good faith that the citizens of Pierce County and City of Tacoma did in building Cheney Stadium.

Mr. Haley agreed with Dr. Herrman's contention that the City should

hold out for a longer contract.

Mr. Finnigan felt they should recognize that the Giants have given Tacoma good ball games and should go along with this request for a one year agreement.

Mr. Bott asked if the County Commissioners were willing to go along with the one year agreement.

Mr. Rowlands said he assumed they would rather have a five year agreement, but thought they would go along with the one year agreement.

Mrs. Price said, if they could not agree on a five year term, they should accept the one year so they would not lose the club entirely.

Mayor Tollefson asked when the agreement had to be signed.

Mr. Rowlands said they would like to have it out of the way if at all possible by October 1, 1964.

Mrs. Price moved that the extension of the lease agreement be amended

to one year, rather than five years. Seconded by Mr. Johnson.

Mayor Tollefson said he would like to know if the Pierce County
Commissioners would go along with the five year contract before this is acted
upon, as this is a joint operation. He added, the City has nothing in writing
from the Commissioners regarding their decision.

Mr. Rowlands 'said they would ask for a written opinion from the County Commissioners on this matter.

Mr. Haley moved to amend Mrs. Prices' motion, that the Resolution be postponed for one week, until Sept. 29, 1964, and in the meantime the Council be informed by written memorandum of the County's feelings on the matter. Seconded by Mr. Cvitanich. Voice vote taken, Motion carried.

Amending Title 11 of the Official Code of the City relative to parking zones.

Mr. Murtland submitted a proposed amendment to the ordinance deleting some of the areas. He said he did not believe there was a need for more parking spaces for traffic control. He pointed out he had observed the areas at different times of day which aided him in recommending these deletions from the ordinance.

Mr. Murtland moved to delete the areas on Tacoma Ave. and both sides of Tacoma Avenue above and below as the area affected, Baker St. and South 7th also to delete any 10-hour parking zones. Seconded by Mr. Finnigan.

Mr. Bott said he was also not convinced that the additional parking meters were needed for traffic control in some of the areas.

Mr. Ralph Turco, Attorney, was present to represent the Tacoma Avenue Citizens Club of South 8th to 15th Sts along Tacoma Avenue. He stated there wasn't any particular parking problem in this area and they were protesting the installation of parking meters. He added, meters would hinder business coming into the area as people do not like to shop where parking meters are installed when they can shop only a few minutes away without the presence of parking meters.

After some discussion, roll call was taken on Mr. Murtlend's admendment to delete the parking meters in certain areas and the 10-hour parking zones. Ayes 5; Nays 4; Herrmann, Johnson, Price and Mayor Tollefson, Motion carried.

Roll call was taken on the ordinance as amended, resulting as follows.

Ayes 7; Nays; 2, Finnigan and Cvitanich. Absent 0. The Ordinance was declared passed by the Chairman.
