The meeting was called to order by Mayor Johnston at 7:00 P. M.

Mayor Johnston asked if there were any outssions or corrections to the minutes of any 19th, 1970.

Mr. Cvitanich moved that the minutes of May 19th, 1970, be approved as submitted. econded by Mr. O'Leary. Voice vote was taken. Motion carried.

#### HEARINGS & APPEALS:

15 **24** 805

a. This is the date set for hearing for the rezoning of the north side of So. 12th between Proctor and Adams Streets from an "R-2" to an "R-4-L" District. (petition of Gus J. Paine)

Mr. Buchler said the area requested for rezoning is the section at South 12th and Adams. Some of the property owners within the area did not object to the resone, however, some letters were received favoring the rezone. One house in the area has been a problem where vandals have done considerable damage and the residents would like the area rezoned for construction of a six-plex. No one appeared to protest. Dr. Hermann moved to concur in the recommendation of the Planning Commission that the rezone be approved. Seconded by Mr. Cvitanich. Motion carried.

b. This is the date set for hearing for the rezoning of the southwesterly side of Center Street between Cheyenne and Tyler Streets from an "R-2" and "R-4-L" to an (-5)" District. (petition of S. D. Wattles)

Mr. Buehler, Planning Director, explained the property to be rezoned is an area of approximately 11 acres. The site is located on a topographical incline, on an arterial street and is at the proposed juncture of two freeways, SR-16 and the Hannah-"ierce Expressway. The applicant has agreed to a number of specific items regarding the site development.

Mr. Hugo Hartnack, a member of the audience, stated that he owned the property scent to this particular property from Center St. to Wright Ave. on the west of ler Street. He felt it should not be considered for building duplexes, but for conservation use.

Mr. Buehler explained that he had talked with both Mr. and Mrs. Hartnack relative to the rezone. He added there are traffic problems at the intersection of Center, Santz and Tyler Streets. He thought that Mr. Hartnack should have a definite plan for his site and file for a rezone. The Commission informed him of this at a previous "R-4-L" rezoning hearing in the area. The front of Mr. Hartnack's property

along Center St. is limited access and it will be necessary to work out the traffic problem on a specific plan. He was advised that application forms can be obtained from the Planning Dept.

Dr. Herrmann moved that the resolution be adopted. Seconded by Mr. Finnigan.

Mr. Gary Sullivan, Director of Urban Renewal, explained the job description and personnel requirements of the position. He thought only one person would be required to handle the job and in his judgment, a redevelopment agent was necessary.

Mrs. Banfield questioned what Mr. Weese's duties were since there is no property or resident to relocate.

Mr. Sullivan replied that in addition to the relocation activities, Mr. Weese is involved in property management, maintaining the site office and providing relocation services.

Mr. Dean asked if this would be a permanent position.

Mr. Sullivan explained this would be temporary insofar as Urban Renewal is temporary. It will be permanent to the extent that there will be people to relocate when the owner participation phase is completed.

Mr. Sullivan added, the plan for the mall will be coming before the Council soon when the Council will be asked to render its judgment. This will create a tremendous amount of work in respect to contacting owners. If this does not develop then it would lessen the need, but assuming that these matters go forward, it would be permanent. Mr. Weese can handle what is before us now, but property is being purchased and there are 100 individuals that will have to be located and the load will be increased, he added.

Dr. Herrmann moved that the resolution be adopted. Seconded by Mr. Finnigan. Voice vote was taken on the resolution, resulting as follows:

Nays 0. Absent 0. The Resolution was declared passed by the Chairman.

#### Resolution No. 20711

Expressing the intent of the Council to restore staff personnel to assist the Human Relations Commission.

Mr. Finnigan moved that the resolution be adopted. Seconded by Dr. Herrmann.

Mr. Willie Stewart, HRC Chairman, spoke in favor of the resolution. He felt Tacoma needs an effective, staffed Human Relations Commission and urged the Council's support.

Mr. Finnigan said that he initiated this resolution and it has had six months to try to operate without a staff, which has been very difficult for people from various walks of life in the City of Tacoma whohave volunteered their efforts to try to better conditions in the City, without professional guidance. The ordinance was not drawn hurriedly. It was given a tremendous amount of consideration over a long period of time and was re-written and revised and re-submitted and was done so with the full purpose of trying to achieve something that they felt would be an instrument to benefit all the people in the City of Tacoma. He felt it was a small price to pay for improving the conditions among the human element of the City and urged the Council to support the resolution.

Mr. Cvitanich said he finds himself in the position where he agrees with principles of a commission, but said it would be compounding a tragic mistake to hire a full-time Director. He and several Council members had indicated, the former director had gone far beyond the scope of the commission as it was originally planned and had caused numerous problems that hampered the commission.

Mr. Finnigan said he knows that most of the Council members recognize that there is a need for a Human Relations Commission and what has happened in the past is something from which we are all going to learn. He appealed to the Council to give them the funds to establish a full time paid director.

Mayor Johnston explained if people are willing to serve the City on this Commission, they should be given the same consideration in regard to their time that the Planning Commission receives and be given a staff with whom to work. He thought it quite unfair to the Human Relations Commission to deny them a staff based on the fact that there was a terrible personality conflict existing between members of this Council and the previous director. This is a Commission of distinguished citizens who recognize the need for human relation considerations in the City that are qualified and wish to serve.

Mr. Jarstad said he thought that a limited staff attached to a Human Relations

Commission, one who could co-ordinate matters on a paid basis, is what is needed for the City. The job to be done is to co-ordinate, audit and analyze everything that is going on all over the City. The Council should have confidence in their own ability to select the right kind of leadership and guidance to do the job that it set out to do.

Mr. Zatkovich said he had attended a fiv meetings of the HRC and asked what were their accomplishments. They had nothing to offer and admitted that they had not accomplished anything. He felt this would be a waste of money at this time to pay a director and noting that nothing had been accomplished. He added with the State Board very ably taking over, he didn't think they needed another board to overlap, especially where there isn't any cooperation.

Dr. Herrmann said at the time the ordinance was passed for the HRC, it was modeled after ordinances that were already in existence in several major cities. If the majority on the Council doesn't believe that these matters are important to identify and study existing and potential areas, and that these objectives are worthwhile, the Council should vote down the resolution.

Mr. McCormick, City Attorney, said, as he recalled when the Board of Discrimination was set up, the Open Housing Review Board was a part of that act and the enforcement and the procedure was set up so that all complaints would be processed through that board. The Council indicated at that time, the HRC did not want the Commission to be the administering group of the act which set up against discrimination and that was where the big controversy arose as he recalled.

Mr. Cvitanich said that the former director led people to believe that he had made arrangements with the State Board Against Discrimination contractually to handle the cases of discrimination in the City of Tacoma, when the fact of the matter is by State law and ordinance, the only legislative group charged with that responsibility was the Open Housing Review Board.

Mr. Dean thought that the City's offer to assist the ODI by acting as a CAP agency in this City indicates the City's willingness to get in and support human relations in all phases. The question many of the Council have is whether or not this particular endeavor is a separate endeavor that should come under the City. The Council is stepping in right now to offer its services as a CAP Agency to take over the entire ODI program which he believes has something to do with human relations.

Mr. Wallace Walker explained when the ordinance for the Human Relations Commission first came before the Council, he spoke in favor of the ordinance and everyone, including the Council, passed it unanimously. Since then, the HRC turned into a haven of rest for a group of phony educators and phony administrators. He felt there are other programs that are willing to do a job for the citizenry and one is the State Board Against Discrimination.

After some discussion, roll call was taken on the resolution, resulting as follows:

Ayes 4: Finnigan, Herrmann, Jarstad and Mayor Johnston. Nays 5: Banfield, Cvitanich, Dean, O'Leary and Zatkovich. Absent 0. The Resolution was declared LOST by the Chairman.

Motion was made and seconded to suspend the rules so as to hear a citizen, Sylvia Horak, speak to the Council. Voice vote was taken and approved unanimously.

Miss Horak read a petition to have a traffic signal installed at the intersection of 56th & Portland Avenue to insure the safety of school children crossing at that intersection during morning and evening peak rush hours.

Mayor Johnston said that he would refer the request to Mr. Oles, City Manager, who in turn will have the traffic engineer explore the problem.

Motion was also made and seconded to suspend the rules to reconsider Ordinance No. 19122 regarding School Bus Fares. Voice vote was taken and approved unanimously.

# Ordinanse No. 19122

Amending Section 12.12.010 of the official code to change the transit fares for school children within the City to twenty cents, effective as of July 1, 1970.

Mr. Jarstad explained that the Council did not want to impose a burden on the private schools, but at the same time are faced with deficits in the transit system. He added, the BASH organization assists the private schools in this area where they need help. He said he asked the people in BASH if they would, from their funds, see their way clear to subsidize the private school children the extra five cents for school bus fares which is necessary for the remainder of this year. It is anticipated if the private students who are using the buses every day, pay their fare both ways, not figuring any absenteeism, it would be less than a \$6,000 contribution to subsidize.

Mr. Jarstad added, Mr. Oles has given a figure of \$92,000 that the City would receive from the State for transportation for the public school students. He said he hoped that BASH would help in this way as it would be serving a purpose for which the organization is set up and at the same time, it would be contributing to something City-wide on behalf of all of the people who contribute to that organization. He hoped that they could work this out. Mr. Jarstad said he had made a request of BASH, but they do not have the people in the City at the moment to give it consideration. He thought perhaps the ordinance could be tabled for a period of two weeks.

Mr. Oles said that the 20¢ school fare was a premise upon which the current budget was based and should the City fall short by reason of failing to adhere to this, he was rather sure that the State Auditor would require a cut in some other area equivalent to the amount that would have been lost. The amount of money involved is about \$92,000 for the year, but with regard to the current budget, it would be for only the balance of the year for which the City is responsible. On the average of 6,000 public school pupils daily, this amounts to 10c a day. For the additional 5¢ fare for the Fall term, this would be \$43,800. He added, he would regret losing \$43,800, but fortunately Mr. Jarstad came up with what seemed to be a very excellent idea and that is to ask for a private subsidy for the children of the private schools, in view of the fact also that the public school children are in fact subsidized by the State to a much greater extent. Father Williams and his group were content with the 15¢ fare but objected to the additional 5¢, which means 10c daily for the pupils involved. The additional 5c raise for 1400 private school children, daily rides for the Fall term would amount to \$5100. He asked if the Council would postpone action for a week or two until Mr. Jarstad explores his proposal.

Motion was made by Mr. Dean and seconded by Mr. Jarstad that Ordinance No. 19122 be reconsidered and brought before the Council in two weeks, June 16. Voice vote was taken and was carried.

#### Resolution No. 20172

Authorizing the expenditure of \$500 for the City's contribution to the Fourth of July Festival and Show.

Dr. Herrmann moved that the Resolution be adopted. Seconded by Mr. Zatkovich.

Mr. Cvitanich wondered why the \$500 couldn't be raised in the private sector of the community instead of using tax-payers' funds and secondly, if \$500 is granted to the TAC for fireworks, who is to say that other organizations such as the Tacoma-Pierce County Soccer Federation, the various Boy's Clubs in the community, etc. would expect a donation. He asked where does the Council draw the line. He added a reduction was made in the 1970 budget for a contribution to the Daffodil Parade, Tacoma Symphony: these were all reduced because of the deficit in the budget. He added he is opposed to the appropriation.

Mr. Zatkovich explained of all the various organizations in the City, the TAC contributes much to the City. He feels that the TAC deserves some consideration. He felt the Council should contribute the \$500.

Mr. Jarstad said, there is a strong movement in the City by Veterans' organizations to stage a parade which might be the beginning of an annual event that could really amount to a great thing here in Tacona, and he could see the fireworks display being a part of this growing 4th of July celebration. He added he would support it especially this year.

Voice vote was taken on the resolution, resulting as follows:

Ayes 5: Finnigan, Herrmann, Jarstad, Zatkovich and Mayor Johnston. Hays 4: Banfield, Cvitanich, Dean and O'Leary. Absent 0. The Resolution was declared passed by the Chairman.

Mr. Oles, City Manager, asked the indulgence of the Council to bring in a matter out of order. He added it should have been in a resolution form, but because of the time element, there was no opportunity to prepare the resolution. The matter is in regard to a space over at the airport for a heliport. He asked the Council to adopt by a motion authorizing him to prepare a resolution for next week's meeting to formalize the action. The rules were suspended to allow the matter to be brought before the Council.

Mr. Oles said this would require a motion authorizing the City Manager to enter into a lease with Great Western Helicopters for 596 square feet of space at the air port at \$3.00 a square foot which would amount to \$1728 per year plus \$120 for water and power. If this motion were approved, a resolution would be drafted for next week's agenda formalizing the action. Great Western is anxious to get settled by the 10th of June as they have a FAA certificating examination which they had to be set up for and that wouldn't give them enough time on the next Council meeting for them to get set up to get the phones in, etc.

Mrs. Banfield asked why this was just brought in tonight.

Mr. Bonney, airport manager, said he didn't know about it until this morning. Mr. Cvitanich said he doesn't appreciate the manner in which this is being presented to the Council under the suspension of the rules, whereby depriving the people of the opportunity of hearing this information and discussing it and knowing what is going on. He added he appreciates what Mr. Oles is trying to do, but the fact the Council is giving the authority tonight to do something and then formalizing it next week by resolution, he did not think this was fair.

Mr. Dean wondered if it were legal for the Council to make a commitment dated the 3rd of June based on something which they do not have before them.

Mr. McCormick explained that another member of his staff draw the lease and it Was checked over by Mr. Hamilton, Chief Assistant City Attorney, that afternoon and apparently is in proper form. This was received in his office by 4:15 this afternoon and didn't have time to draft a regular resolution. It was his understanding that Great Western cannot wait until next Council meeting for authority to move in because the telephones had to be connected, etc. Mr. McCormick said he suggested as did Mr. Oles that they wait until the next Council meeting which is the normal procedure so the Council would have the opportunity to look at the agreement, but he was informed by Mr. Bonney, airport manager, that the tenant had to be in there and in operation and hooked up by the 10th. The next Council meeting would have been too late.

Mr. McCormick said what they are actually asking is that the Council determine tonight by motion as to whether or not to let these people move in.

Dr. Herrmann said he was satisfied that this lease is in the proper form and all they are doing for a period of one year is leasing 576 square feet at \$3.00 a foot.

After considerable discussion, Dr. Herrmann asked that a resolution be brought before the City Council next week that encompasses an agreement with the Great Western Helicopter Line. Seconded by Mayor Johnston.

Mr. Cvitanich said he would move to amend the motion that we agree with the concept of the helicopters landing at the air port, agree with the concept of the lease and then next week ratify the lease, which will give the Council members an opportunity to check over the lease. The motion by Mr. Cvitanich was seconded and carried unanimously.

# Resolution No. 20713

Appointing Dr. Ronald E. Magden as a trustee on the Library Board for a term expiring August 3, 1973.

Mayor Johnston moved that the resolution be adopted. Seconded by Mr. Finnigan.

Mr. Cvitanich moved that the resolution be postponed for one week, until June 9th. Seconded by Mr. Dean. Voice vote was taken. Motion carried.

The Resolution was postponed until June 9th.

#### Resolution No. 20714

Outlining future labor negotiations policy and rescinding Resolutions Nos. 18848 and 20628.

Mr. Cvitanich moved that the resolution be adopted. Seconded by Mr. O'Leary.

It was moved by Mr. Cvitanich that the words "requests or their own" be deleted from the third paragraph. Seconded by Mr. Jarstad. Motion carried,

It was moved by Mayor Johnston that wherever the term "Management Committee" occurs in this resolution that it be deleted and the term "Management Team" be inserted. Seconded by Mr. Zatkovich. Motion carried.

Mr. Cvitanich motioned to add an amendment to the Collective Bargaining clause. As it now reads "Relationships among the salary rates of the various classes of City employment". Add amendment as follows: "Job responsibility, work load, and the hazards of employment shall be considered in comparative salary data." Mr. Cvitanich moved that the above amendment be adopted. Seconded by Mr. Dean. Motion carried unanimously.

It was moved by Mr. Cvitanich to add an amendment to Sec. 5 Union Membership. Add amendment "Union Representative. Shall be permitted reasonable access to City work areas for the purpose of conducting legitimate business which concerns both parties." Seconded by Mr. Dean. Motion carried unanimously.

John Willis, chairman of the Joint Labor Committee, said some of the unions have contacted him and some haven't, but he thought they will go along with the Joint Labor Committee's recommendation. He talked with Mr. Dillishaw of the Tacoma Police Dept., Local 224, and said he is in accord with this resolution.

Mr. Cvitanich moved that the resolution be adopted as amended. Seconded by Mr. 0' Leary. Voice vote was taken on the resolution, resulting as follows:

Ayes 8: Banfield, Cvitanich, Finnigan, Herrmann, Jarstad, O'Leary, Zatkovich and Mayor Johnston.

Nays 0. Absent 1: Mr. Dean (temporarily).

# FIRST READING OF ORDINANCES:

Ordinance No. 19125 (postponed from the meeting of May 19th)

Amending Section 6.52.130 of the official code relating to licensing taxicabs in the City limits of Tacoma.

This ordinance was continued so that Mr. Tollefson, attorney, who represented the cab companies could present some additional material for the Council's consideration. Mayor Johnston asked Mr. Tollefson if he had anything to add, and Mr. Tollefson said he had no further comments.

Mr. Cvitanich explained that from the various letters and statistics provided the Council, he thought the Council should grant the increase.

Mr. Zatkovich wondered how the cab rates compared with those of the city of Seattle and Portland. Mr. Clarence Clark, Manager of Yellow Cab, stated that Seattle had a 70¢ flag that was put into effect a year ago. Bremerton, Everett have the 70¢ flag. Fortland has a 60¢ flag with a 2/10 of a mile variation on the ime. He said the mileage basis was not being changed. The increase that is being asked is less than a 20% increase.

Mr. Dean asked what the current fee was in Tacoma. Mr. Clark replied that it was a 50¢ flag drop, but they are asking to amend the ordinance to change the rate for the first 1/5th mile or fraction thereof for one person to 80¢, formerly it was 50¢.

Mr. O'Leary said that he would hope that this was the maximum and that other companies could charge less if they so desire. This is strictly setting a maximum.

Mr. Bob Farrel of Teamsters Local 313 said that all the main cab companies are hiring union men with union wages guaranteed, health, welfare and pension plus commission. So he guarantees that the cab companies wouldn't flood the City with cabs.

The ordinance was placed in order of final reading.

#### Ordinance No. 19136

Amending Title 6 of the Official Code relative to taxation.

Mr. McLennan, Director of Tax and Licenses, explained at the meeting of May 19th, the Council asked Mr. Oles to direct him to meet with the bank officials to determine from their figures on a fair and representative basis, what the receipts and deductions they were talking about and the tax rate which would be applice able. He said attached to the ordinance is a schedule showing the results of the consultation as computed.

The ordinance was placed in order of final reading.

# Ordinance No. 19137

Changing the street name of that portion of Highline Rd. south of 29th St. N. E. between 58th Ave. N. E. & 59th Ave. N.E. & 60th Ave. N.E. extended to be Highline Pl.

The ordinance was placed in order of final reading.

#### FINAL READING OF ORDINANCES:

# Ordinance No. 19126

Appropriating the sum of \$98.159.00 or so much thereof as may be necessary from various City funds for the purpose of paying increased salaries and wages and declaring an emergency.

Mr. Zatkovich wondered if the union representatives were satisfied with the previous ordinance. He believed that a representative of one of the groups was not satisfied according to the way that this ordinance is drawn up.

Lilia Piva representing Local 120 said that when they went to arbitration, there vas a committee formed and each labor union involved at that time said they may not agree, but will abide by whatever comes out of this committee. Local 120 was one of those unions. They don't agree with them, but will abide by it.

Mr. Zatkovich said he did not approve of this being presented in all one package. He felt the ordinance should be amended to give everyone something.

Mr. Cvitanich said the ultimate responsibility is not to the City employees, out for the taxpayers of this community. He said he cast his vote for the police and firemen without any reservations whatsoever; he would do the same under the same circumstances next year if he has the opportunity. He added, if they are going to deviate from the established recommendations of the Management Team, then it should be the Council's responsibility to make the necessary concessions to the various crafts as they saw fit. Ultimately, it is their responsibility. He said he could not in good conscious support the ordinance at the expense of the general taxpayers of this community.

Mr. Dean said that although he disagreed with putting it into the Management Team and having arbitration, he is now in a position where the Unions arbitrated in good faith and have agreed in this particular case to these terms based on the fact that the Council said that this is what the Council wanted to do and in all good faith, he will have to go along with the majority of the recommendations.

Mr. Finnigan said he was opposed to the procedure. He felt that there are many employees thoughout the union that deserve a raise as much as the fire and policemen and felt it a shame that they were not all considered at the same time. He said he would also have to oppose any increase for any further employees.

Lily Piva urged the Council to vote for the amendments and pass the ordinance as presented and keep in mind to make further adjustments for next year.

Mr. Zatkovich said for many years the police and fire personnel were fed the "bones" as they didn't think the police and firemen deserved any holidays or regular raises like the rest of the employees. It was only thru persistence that they were finally able to be in the position where they are equal or on a par with other cities in salaries.

Mr. Zatkovich moved that the ordinance be amended to allow the gardeners their tain gear. Seconded by Dr. Herrmann.

Mr. Oles suggested that the Council adopt the ordinance as proposed to give the Management Team an opportunity to work out in detail the amount and bring in the complete information regarding the change they desire.

Mr. Cvitanich felt this should be resolved tonight.

Mrs. Pive was asked if she knew what amount this would be. She replied the suits alone cost \$27.00. There are 15 or 16 people involved; 12 are from the Utility Dept. and 3 from General Government.

Mr. Cvitanich asked Mrs. Piva how far below the Pierce County salary is the milk sanitarians and meat inspectors now since they received a one-half range increase. She replied \$15.00 a month in each category.

Mr. Erdahl, Director of Public Utilities, said since Mrs. Piva agreed to postpone further discussions on salary adjustments until next year's budget hearing, he hoped that next year they can correct the inequities.

Mayor Johnston called for a roll on the motion to amend the arbitration committee's recommendations to grant the gardeners their rain gear, hats, pants, etc. Ayes 6: Dean, Herrmann, Jarstad, O'Leary, Zatkovich and Mayor Johnston. Nays 3: Banfield, Cvitanich, and Finnigan. Absent 0. Motion carried.

Motion was made and seconded that the rules be suspended so that Mr. Fortier could speak.

Mr. Joseph Fortier representing the Labor Foreman II and the Street Maintenance Foreman of the Public Works Dept. spoke on their behalf for a one step increase. He hoped that one of the Council members would make an amendment to this particular ordinance to give the Labor Foremann II and the Street Maintenance Supervisor who are the

Mr. Cvitanich said why couldn't the City of Tacoma submit Form 71 on an interim basis and work the mechanics and the details later. He feels that there is a lot of road blocks being put in their way deliberately. This Council should move forward and get it done regardless of the meeting. Get it on an interim basis from Washington, D.C. as those are the people that are ultimately responsible. He added, he was assured that the office of CEO will provide all the technical assistance the City needs without hiring consultants.

Mr. Cvitanich moved that the City Manager proceed with submitting the application Form 71 as a CAP Agency immediately. It was seconded by Mr. O'Leary.

Mr. Oles said he would certainly want to follow those instructions, but he was advised by the legal department, who is preparing the data which entails a great deal of time, that one or two things have to be decided; one being the manner of selection of the representatives of the beneficiaries which they have not come to any conclusion which would be a pre-requisite to filing the necessary papers with the regional 0.E.O. office.

Mr. O'Leary moved to amend Mr. Cvitanich's motion, whereby the City Manager is again authorized and directed to utilize the full power of his office and of the City Attorney's office plus every available means at his disposal; the application of the City of Tacoma be fully recognized and funded as a Community Action Agency in accordance with provisions of Section 210-E under the office of Economic Opportunity Act as amended, and further, to call upon Congressman Floyd B. Hicks, U. S. Senators Warren Magnuson and Henry Jackson and any others who assistance may be necessary in helping expedite the early and favorable action of the Regional Office and the economic opportunity regarding the very early official recognition of Tacoma as a CAP Agency to govern and administer any poverty funds programmed within the City of Tacoma. The City Manager further is requested to work in close co-operation with the Board of Gouncy Commissioners in the achievement at both ends so that the take-over date of division of poverty and equivalent budgetary matter may be coordinated with the results and efficiency in a minimum of any disruption of service to the low income and the core of the City and the County. #### COMMENTS BY MEMBERS OF THE COUNCIL:

Mr. O'Leary congratulated members of the Marine, Industrial and Kiwanis Club for showing their contempt for Dr. Annis who refused to salute the Flag of the United States at their meeting this morning. The majority of their group walked out in contempt of this person.

Mr. Oles said he was reminded of one more duty that he failed to perform and that was that Mr. Bond is in dire need of one additional camera.

Mrs. Banfield asked Mr. Oles if he would get some information from other cities that have constructed malls both from private enterprise and also through Urban denewal projects - to see what results they have had and any other valuable information. Also she felt that they should look into passing an ordinance relative pornography material. If it isn't now on the books, it should be.

Mr. Oles said a report just came in the other day on what our legal situation is and he thought it wasn't very good. We have some ordinances and a state law, but they to not get very much support from the judiciary. It seems that they have looked at some of the decisions from the Supreme Court which says that there is no such thing as pornography and that anything goes. He has asked the Legal Dept. to obtain the only 236 encouraging Supreme Court decision he has heard of recently which came out a week ago affirming and supporting the Georgia law. He added he would try to get the Georgia law and read the decision in detail. He proposes to do something drastic in this repard with the Council's support.

Mrs. Banfield said she understood that the committee for the Charter changes have one more meeting, at which time she would appreciate if the Mayor would call a meeting with the Council so that they can have a resolution drafted for the agenda.

Mr. Oles replied that the committee has completed its work and has put all of its proposed amendments into a new form. The Legal Dept. will now have to incorporate 200 these changes into one single document. Then the committee proposes to meet once more and see that this has been done to their satisfaction.

Mrs. Banfield said she didn't see why they have to wait three weeks for the Legal Dept. to prepare this. She thought the Council could get together with the committee, then they can forward it to the Legal Dept. to draw up some kind of documentation.

Mr. Oles said that there would be quite a lot of work to incorporate all these changes, starting from A to Z. They also have to reduce the various proposed changes to the form of resolution because the resolutions maybe as many as 7, 8, or 9 in number because there has to be a separate resolution to cover each one of the proposed areas of change. So the whole thing is a little more complicated than it sounds, but he is sure that the Legal Dept. will be using their best endeavors to get it out in the next week or two. It is much more work than one is likely to think, he added.

Mrs. Banfield said that she is quite disturbed with the situation in the City of Tacoma. Its incredible that the American Citizen finds himself in the position of internal war that is actually in existence. Mrs. Banfield referred to a copy of an article taken from the American Mercury Magazine, Summer, 1970, issue, entitled, "In the Clutch of the Octopus, subtitle, "Insensitivity Training Conspirators Enlarge Their Network". It is an excellent article that tells exactly what is happening in the country today and it is time we citizens get organized and wise up to what is going on. She asked that a copy of the article be attached to the minutes of this meeting.

Er. Zatkovich stated in regard to Dr. Annis refusing to take part in the singing of America, he should have been thrown out bodily. He thought that the Council should go on record to recommend the school authorities to discharge him. Teachers like him are a good part of the reasons why we have so many problems now by young people on the campus and other places. He commended the congregation of the Epworth United Methodist Church for getting rid of their problem. This fellow is still engaged and involved in radical movements around here and maybe he has finally found what he wanted aside from preaching in the church. He also briefly commented on the Fiasco that took place in Seattle relative to the man that was caught in the act of bombing a place and commended the Seattle Police Dept.

Mr. Dean asked Mr. Oles if the Council could get together with the Park Board to see if they could be of any assistance to them in setting up an ordinance which will allow them to do the job which they as elected officials were given the power to do. It appears that the Judge in this case found something which the Park Board has been acting under for years, but it appears at this time some influence has been exerted and now the Park Board does not have the authority to make its own regulations. He asked Mr. Oles to find out if the Council can be of any assistance to the Park Board in giving them some regulations whereby they can control some of these situations. \* \* \* \* \*

But something else is even more du turbing, for it shows how dangerous and seductive the "brotherhood of humanity" line can be, how it can fool those who should know better.

In Rev. Billy Graham's own magazine, Decision, for January, 1969, there was an editorial in favor of what was, of course, euphemistically called "sensitivity training"! Said the editorial, supposedly the voice of Billy Graham himself:

"We can thank our canine friends for the idea of sensitivity training. The U. S. Air Force sentry dog training manual says, The term sensitivity refers to the type and degree of response the dog shows to a certain stimulus.' We should like to co-opt the idea of sensitivity training in 1969 and put it to work in the Church of Jesus Christ. Here are some ways Christians could possibly make use of it."

Then the ways are listed. It is a shocking thing to realize that it was the Russian scientist, Pavlov, who first studied the conditional reflex of brainwashing — on dogs!

On my last two speaking tours people would, understandably, get upset when I mentioned Billy Graham. "Are you saying that Billy Graham is a communist?" one young woman in New Jersey demanded.

"Of course not," I answered. "But from someone, somewhere, he has received the wrong advice. Won't you, and others like you, write to Billy Graham and share with him what you know about so-called 'sensitivity training?""

"Yes," she said. "I'll do that. I'll do it tonight."

I then suggested that when she wrote Rev. Graham she send him a copy of Look for April 1, 1969. For in that issue, in an article titled "Sex for Credit," Professor Gerhard Neubeck admits, (that's why sex ed is pushed so frantically), but they are also "desensitization." Neubeck uses exactly that word. We are grateful to him. However, noting that the date of the article was April Fool's Day, I would not be surprised if Prof. Neubeck now wants to take it back. After all, he is not, by any stretch of the imagination, against desensitization. He is for it, as is Look magazine itself.

#### **Maslow Admission**

In Pace magazine, December 1969, we had another confession, this time by Abraham Maslow himself. (Followers of Group Criticism like to confess, you'll notice. In fact, they can't help it). For in an article revealingly called "The Unnoticed Revolution," Maslow, now 61, uses the term Eupsychian Network. It is the first time that term has appeared in a national publication other than THE AMERICAN MERCURY.

Apparently he could no longer hold it in. He had to brag. And why not? The *Eupsychians*, *Illuminati*, call them what you will, are winning.


But the struggle is not yet over.

Since the first of this year a program was started in, of all places, New Guinea! One can only wonder what the results will be when the head hunters there become more insensitive than they already are. For if there is one thing that Group Criticism (or Sama Kritica, as the Russian secret police labeled it), does, it is to cause members of even the most civilized groups to "sharpen their knives" for other members who criticize them with too much enthusiasm.




As you probably know, the Commerce Department does not have regulatory authority over oil exploration and, since the land areas concerned are owned by the State of Washington, we are limited as to the assistance we might provide. We are not in a position to challenge State officials on the merits of leasing these lands to oil companies. However, we believe that if any industrial development is undertaken it should not destroy the scenic value of the area, or bring about any pollution of the air or water which can be avoided.

Thank you for bringing the views of the City Council of Tacoma on this important matter to our attention.

Secretary Romney has sent your recent letter and accompanying resolution regarding the proposed leasing of Puget Sound shorelands for oil drilling to this Division for review and response.

We can understand the concern of Mayor Johnston and the members of the Council about the proposal. Certainly the many oil spills and other mishaps of recent months give reason for apprehension about the environmental impacts of oil in marine areas.

This Department has no authority with respect to such activities at the Federal level. At State and local levels, we can intercede in such matters only where Departmental interests are involved, or where the State or local government is participating in a program or activity which we administer.

In marine drilling, we understand that the Secretary of the Interior has substantial authority; if you have not done so, we suggest that you write to him. Similarly, it would be well to keep your Congressional delegation fully informed

I hope that some effective resolution of this matter will prove possible.




