### CITY COUNCIL MINUTES

City Council Chambers, 4:00 P. M. Tuesday, July 10, 1962

Council met in regular session. Present on roll call 8: Bott Cvitanich, Finnigan, Herrmann, Murtland, Price, Steele and Mayor Tollefson. Absent 1, Haley.

Mr. Steele moved that the minutes of June 26, 1962 be approved as submitted. Seconded by Mr. Finnigan. Voice vote taken. Motion carried.

### HEARINGS & APPEALS:

This is the date fixed for hearing on the petition submitted by Donald 225 Lemmon for the vacation of property on So. 14th between the east right- 303 of-way line of Proctor St. and the east line of Ridgedale Add. also adjoining alley to the north.

New Hearing date - July 31, 1962.

Mayor Tollesson explained that a new hearing date for the vacation of property on So. 14th between the east right-of-way line of Proctor St. and the east line of Ridgedale Add. also adjoining alley to the north, Don Lemmon, petitioner, had to be set due to the change in time of the Council meeting.

#### Resolution No. 17125:

Authorizing the removal of overgrown blackberry vines, brush and grass because of rodent infestation at 4423 So. 7th.

Mrs. Price moved that the Resolution be adopted. Seconded by Mr. Steele.

Dr. Herrmann asked for an explanation of this Resolution.

Mr. Ray C. Smith, Chief of the Sanitation Division, explained that Resolutions like this one are requested because of complaints received by the Health Department concerning rodents in an area. The area is then inspected and the property owner is notified. In this particular case the property owner lives out of town and could not take care of the infestation; therefore, the City will correct the condition at the owner's expense.

Mr. Rowlands stated the procedures involved in matters of this nature are very time consuming. Usually approximately 2 1/2 months have passed before the conditions have been met and a Resolution is requested.

Voice vote taken on the Resolution.

The Resolution was then declared adopted by the Chairman.

#### Resolution No. 17126:

Authorizing the agreement with the State Highway Dept. for the cost distribution for construction of future structures & necessary roadway connections to be known as "Nalley Valley Vi aduct".

Mrs. Price moved that the Resolution be adopted. Seconded by Mr. Steele.

Mr. Rowlands explained the cost of this viaduct which will lead into Bantz Blvd. will be borne by the Federal Government, the State of Washington and the City of Tacoma. The City's share is \$140,060.00, which is 24 or 25%, and this amount would be paid from the Arterial Struet fund. The 6-year Capital Improvement Plan includes the vialuct. Mr. Bugge of the State Highway Dept. wishes to know the decision of the Council as soon as possible so the State may proceed with the preliminary engineering and right-of-way acquisition.

Mr. Murtland asked what was the financial status of the Arterial Street Fund.

Mr. Schuster, Director of Public Works, stated there is approximately \$350,000.00 uncommitted at the present time.

Mr. Bott said he wished more time to study the Resolution. He then moved to postpone the Resolution for one week, July 17, 1962. Seconded by Mr. Cvitanich. Voice vote taken. Motion carried.

Mr. Steele moved to suspend the rules to bring in Resolution No. 17127 and Resolution No. 17128. Seconded by Mrs. Price. Voice vote taken. Motion carried.

### Resolution No. 17127:

Commending both the Tacoma Giants Team and the Tacoma Booster Club for their excellent promotional activities during their stay in Hawaii.

Mrs. Price moved that the Resolution be adopted. Seconded by Mr. Steele.

Mayor Tollefson said he received a copy of a letter adressed to Govenor Rosellini from N. G. Morgan, Jr., President of the Hawaii Baseball Club, commending the Tacoma Booster Club and the Tacoma Giants Baseball Team for their fine spirit. Mayor Tollefson felt it was appropriate to request a Resolution commending these organizations.

Voice vote was taken on the Resolution.

The Resolution was then declared adopted by the Chairman.

### Resolution No. 17128:

Commending Tacoma Naval Reserve Crew aboard the USS Watts (DD-567) in answering the call to active duty.

Mr. Finnigan moved that the Resolution be adopted. Seconded by Mrs. Price.

Mayor Tollefson stated the men on the USS Watts are primarily from Tacoma. They were recalled to active duty in December 1961 and will be released in August of 1962. He felt it would be appropriate to commend them in appreciation of their performance.

Read by title and passed.

## Ordinance No. 17117:

Repealing Chapter 1.08 of the Official Code and re-enacting said chapter as amended and modified relating to Bond requirements for officers & employees of the City. Read by title and passed.

## Ordinance No. 17118:

Appropriating \$5,500 or so much as may be necessary from the General Fund of the City for the purpose of paying certain expenses of the Tacoma Humane Society. Read by title.

Mrs. Price stated that Mr. Hatfield of the Teamsters Union has requested the postponement of this Ordinance pending further negotiations with the Humane Society.

Mayor Tollefson left at this time. Mr. Murtland presided as Chairman.

### Ordinance No. 17120:

Amending the Official Code of the City relating to zoning by adding a new section 13.06.065-19 to include property on the south side of Wilkeson 270 near So. 73rd St. in a "R-4-L" Low Density Multiple-family dwelling district. (Petition of Hokold Investment Corp.) Read by title and passed.

Roll call was taken on the Ordinance resulting as follows:

## Ordinance No. 17121:

Arnending the Official Code of the City relating to zoning by adding Section 13.06.065-18 to include property on the west side of Pacific Ave. in -7/0 the vicinity of So. 91st St. in a "R-4-L" Low Density Multiple-family dwelling District. (Petition of J. B. Malyon) Read by title and passed.

## Crdinance No. 17115:

Amending Sections 5. 20. 090, 100 and 130 of the Official Code of the 269 City providing for the increase in rates for the Refuse Utility effective 12 of August 1, 1962. Read by title.

Mayor Tollefson stated he had received a communication from Mr. and Mrs. Gilbert, 1506 S. 51st St. protesting the increase in garbage rates.

Mr. Albert Carlson, 5403 South "I" St. and Mrs. M. A. Thomas, 231 So. 70th St., protested the increase in the rates to people on fixed incomes. Mrs. Thomas also suggested that the Garbage Dept. pick up garbage of single residents every two or three weeks.

Mrs. Pearl Brett of 611 N. Cedar protested the rate increase and stated that the sanitary landfill operation for refuse be stopped and a compost

plant be started by the City.

Mr. Rowlands stated there had been no increase in garbage rates for the last five years. Tacoma has what is known as a sanitary landfill, whereas each day the refuse collected is covered by dirt. In that way there is no rodent problem.

Mr. J hn Bronow, Public Works Dept., stated the weekly garbage collection was made compulsory in 1929 because at that time garbage was dumped most anywhere.

Mayor Tollefson said, the Council does not like to increase rates, however, by State Law the Utility must be self-supporting.

Roll call was taken on the Ordinance resulting as follows:
