## FINAL READING OF ORDINANCES:

Ordinance No. 15594.

Amending Section 10 and Section 90 of Ordinance No. 15258 entitled: "An ordinance regulating travel and traffic on the streets of the City of Tacoma; providing a penalty for the violation thereof, etc." (pertaining to Funeral Processions-Sec, 10 and Parade Regulations-Sec. 90.) Read by title. Several of the Council members stated they had questions in reference to the phraseology and language of the ordinance. Hrs. Goering said she thought that some of the wording in the Ordinance should be redrafted, particularly under the definition of "Parade" which means any procession of persons numbering more than 5 marching or walking on the street; except funeral and wedding processions. Mayor Tollefson suggested that the ordinance be postponed for two weeks to May 7th, and he asked the Council members to submit their suggested changes to Hr. Boyle, the City Manager, so that the corrections could be made before the May 7th meeting. As a result of the foregoing discussion, it was moved by Mrs. Goering, seconded by Col. Hooker to postpone Ordinance No. 15594 for two weeks to May 7th, 1956. Carried on roll call: Ayes 8; Nays 0; Absent 1; Battin.

# Ordinance No. 15595.

Appropriating the sum of \$6252.00, or so much thereof as may be necessary, from the General Fund, for the purpose of installing trunk storm and sanitary sewers as a part of the West End Storm and Sanitary Trunk Sewer Systems under Regents Boulevard in the Town of Fircrest; and declaring an emergency making necessary the passage of this ordinance and the appropriation herein contained. Read by title and passed.

### UNFINISHED BUSINESS:

This being the date fixed by Resolution No. 14579, adopted by the City Council on March 26, 1956, for hearing on petition of Tribune Publishing Co., et al, for the vacation of Trafton and Steele from South 19th to South 23rd; South 21st from State to approximately 109' west of Steele; alley between Trafton and Steele from South 19th to South 23rd and alley between State and Trafton from South 23rd to approximately 265' North of South 21st, the Clerk reported the posting of the notices required by law and the filing of an affidavit of such posting. Also reported that a fee of \$50.00 had been paid by the petitioners. The Clerk advised that a request has been received from the Tribune Publishing Co., asking that this hearing be continued to May 7th, 1956 as the officers of the Company will be in New York on April 23rd. It was then moved by Col. Hooker, seconded by Mr. Stojack that the hearing be continued for two weeks, to May 7th, 1956. Motion carried on roll call: Ayes 8; Nays 0; Absent £; Battin.

This being the date set by Council for the hearing on the appeal of Leo Gregorich from the denial of his petition (2-6-56) by the City Planning Commission For resoning from R-2 District to C-1 District property at N. W. corner of Nosth 945th and Orchard Streets, the matter was taken up at this time. Mr. A. M. Ursich,

attorney for Leo D. Gregorich, briefed the Council on the history of the property which his client desires to have rezoned. He said that this property was formerly zoned as a Commercial district and had been used for business purposes for many years. It was rezoned as a residential area during World War II, when housing was critical and very inadequate. Hr. Ursich stated. The rezoning is being requested in order to permit the barbershop, now located across the street, to move to his building as the premises it now occupies does not have adequate sanitary facilities. Mr. Ursich disagreed with the claim made by the Planning Commission that rezoning this property will result in an increase of traffic in the area, contending that no new business will be established, since the barbershop is only moving across the street and therefore the number of vehicles using the streets will not change materially. Mrs. Virginia Baker, owner of the building now occupied by the barbershop, was present and protested the rezoning. She stated that she has had possession of the property for only a short time through an inheritance, and as soon as the estate is settled she had made plans to install proper toilet facilities. Mr. Buehler, Chief Planning Engineer, advised Council that the area one block north of Mr. Gregorich's property, at North 46th and Orchard is now zoned commercial and is adequate to accommodate additional shops and stores. Mr. Arthur Jordan, Chairman of the Planning Commission, stated that new residences are being built to the south of North 45th Street and to the West of Orchard Street, which indicates there is a trend toward residential expansion in this area. Council members asked Mr. Jordan and Mr. Buehler numerous questions about the area and the reasons for denial of the petition. Several Councilmen expressed the desire to have an opportunity to view the property under consideration. It was moved by Br. Humiston, seconded by Col. Hooker to continue the hearing for one week to April 30, 1956. Motion carried unanimously.

Mr. Perdue, Chairman of the City Manager Selection Committee, asked the Council members to meet in the Manager's office following the session to study the applications for City Manager. Mayor Tollefson added that he felt this meeting tonight should be recessed so that official consideration can be given to the applications and choice of a City Manager.

Upon motion, duly seconded and carried, Council at 9:43 P. M. recessed until Wednesday, April 25th, 1956 at 8 P. M.
