Vacating that portion of North 17th Street lying between North Lawrence Street and a point 151 feet east on said North 17th Street, or to the east boundary line of the Cellege of Puget Sound, described as follows: The north 15 feet and the south 15 feet of North 17th Street lying between North Lawrence Street and a point 151 feet east therefrom; and retaining and reserving to the City of Tacoma certain easements therein for the construction, repair and maintenance of public utilities and services. Read by title. Moved by Dr. Humiston, seconded by Dr. Battin to suspend Rule 9 and carried unanimously on voice vote. Mr. Backstrom reported that the portion of the street vacated by this ordinance is not satisfactory to the College, and for this reason the staff recommends the vacation be abandoned. A satisfactory agreement has been worked out with the Utilities Department and in the near future another petition will be presented, he added. Roll was called on the ordinance as follows:

Roll call: Ayes 0; Nays 9; Absent 0. Declared lost on roll call.

It was moved by Dr. Humiston, seconded by Mr. Stojack, that if another petition is filed by C. P. S., the filing fee be waived and the College be credited with the fee paid on the original petition. Motion carried on roll call: Ayes 9; Nays 0; Absent 0.

Ordinance No. 15398. (laid over to this date on August 8th).

Amending Ordinance No. 14793, entitled: "An ordinance to regulate the location and use of buildings and the use of land within the City of Tacoma; to limit the height of buildings; to prescribe building areas and lines, and the size of yards and other open spaces and for these purposes to divide the City into districts (ZONING ORDINANCE) by adding thereto a new section to be known as Section 8I (C-1 Commercial District, property located on either side of 6th Avenue from Proctor to Madison). Read by title. The Clerk read a communication from the City Planning Commission, requesting the Council to postpone this ordinance until after the Commission's September 20th meeting in order to enable further and more detailed study to be made of this matter. It was moved by Mr. Bratrud, seconded by Mr. Stojack to lay the ordinance over to September 26, 1955. Motion carried on roll call: Ayes 9; Nays 0; Absent 0.

Ordinance No. 15403. (laid over to this date on August 15th).

Amending Sections 15, 30 and 32 of Ordinance No. 14793 entitled: "An ordinance to regulate the location and use of buildings and the use of land within the City of Tacoma; to limit the height of buildings; to prescribe building areas and lines, and the size of yards and other open spaces and for these purposes to divide the City into districts." (ZONING ORDINANCE). Read by title. It was moved by Dr. Humiston, seconded by Mr. Stojack to suspend Rule 9 and carried unanimously on voice vote. The City Attorney presented a revision of Section 32 A, as requested by Council at the last meeting in order to clarify the language, which was read for Council's information. Dr. Humiston said he felt the effective date of the establishment of the Board of Adjustment should be included, and it was decided to begin the paragraph with "Effective October 1, 1955". The expiration date of the terms of office was also important, some of the Councilmen felt, and the expiration date of September 30th was also included. It was moved by Dr. Humiston, seconded by Mr. Perdue that Section 32A be amended to read as submitted by the City Attorney, with the effective date of the establishment of the board and the expiration date of terms of office included. Motion carried on roll call: Ayes 9; Nays 0; Absent 0. Roll was then called on the ordinance as amended, resulting as follows:

Ayes 9; Nays 0; Absent 0.

The L. I. D. Committee reported that a hearing was held by the Committee on L TD 4567 on August 16th, for asphaltic concrete pavement with cement concrete curbs and gutters on East 50th Street from East B Street east for 600 feet, at which time the remonstrance was reported as 44.3%. At the hearing it was brought out that a district is being created for a water improvement here and it was felt by the Committee that action on the paving should be deferred until after the outcome of the Water Improvement is ascertained. Therefore the L I D Committee abandoned the district with the proviso that if watermains go in, the Fublic Works Department can re-initiate a new L I D in the area, and makes this recommendation to the Council. IT was moved by Dr. Humiston, seconded by Col. Hooker to concur in the recommendation of the L I D Committee. Motion carried on roll call: Ayes 3; Nays 0; Absent 0.

The L. I. D. Committee reported that a hearing was held by the Committee on L I D 5252 on August 16th, for cast iron water main in East 63rd Street from "B" Street to "F" Street and in "B" Street and "F" Street from East 63rd to East 64th, at which time the remonstrance was reported as 58.31% In view of the large remonstrance, the L I D Committee abandoned the district, and makes this recommendation to the City Council. It was moved by Dr. Humiston, seconded by Col. Hooker to concur in the recommendation of the L I D Committee. Motion carried on roll call: Ayes 9; Nays 0; Absent 0.

At this time Mrs. Goering moved that Rule 7 be suspended in order to give consideration to L I D 4564, Motion seconded by Mr. Bratrud and carried unanimously on voice vote.

Mrs. Goering, Chairman of the L I D Committee, reported that hearing was held on August 9th by the Committee on L I D 4564, for asphaltic concrete paving with curbs and gutters and storm drainage on Cedar Street from 6th Avenue to North 8th Street and on North 7th from Alder to Junett. She read for Council's information a report of the hearing, which stated that the remonstrance was 46.5% and that the remonstrances were overruled by the Committee and the district created with the reservation that if additional remonstrances are filed to raise the percentage to between 50 and 60% the L I D Committee will recommend that the district be abandoned. The remonstrance is now 57% and in accordance with the Committee's promise they have no alternative but to recommend that the district be abandoned, she added. It was moved by Hr. Bratrud, seconded by Mrs. Goering that the remonstrances be sustained and the district abandoned. Motion carried on roll call: Ayes 9; Nays 0; Absent 0.

This being the date fixed by Resolution No. 14347, adopted July 25, 1955 for hearing on petition of A. F. Gratzer (6-27-55) for vacation of South 40th Street from South Union Avenue to South Tacoma Way, the Clerk reported the posting of the notices required by law and the filing of an affidavit of such posting. Also reported that the filing fee of \$80.00 had been paid under a previous vacation proceeding on May 7, 1954 and that no remonstrances had been filed against the proposed vacation. The Clerk read a recommendation from the Public Works Dept. (dated July 19, 1955) that since there are indications that South 40th Street may be required in several of the proposed plans to alleviate traffic congestion at the intersection of South 38th and South Tacoma Way and Union Avenue, it is their recommendation that South 40th Street should not be vacated at this time. A letter was read by the Clerk from the City Planning Commission advising that at its meeting of August 2nd, at the request of the Public Works Department, they recommended that the petition for the vacation of South 40th Street from Union Avenue to South Tacoma Way be denied and at the same meeting passed a motion to recommend that in so far as the present condition of South 40th Street is concerned, maintenance of the status quo would be in the best interests of the City. A letter from the Director of Utilities was read, (dated July 18, 1955) stating that department would approve

the requested vacation subject to reservation of an easement as set forth above and abject to the agreement of the petitioner to pay the cost of rerouting the electric istribution line as specified. Hr. Gratzer claimed What he had shown by photoraphs at the Commission meeting on August 2nd that regardless of future needs for rterchange at So. 38th and South Tacoma Way, there could be no conceivable use for 10 th Street for this purpose. He has had the street in question black-topped at onsiderable cost, and he is asking the City Council in this case to overrule the recommendation of the Planning Commission and grant his petition, he added. Myron alkins, City Engineer, presented maps showing 5 systems to alleviate traffic conestion at South 38th Street, 3 of which contemplate use of South 40th Street for this urpose. As long as there is a good chance that 40th Street might be used, they ust recommend that it be not vacated, he said. After looking the sketches over, r. Jonsen said in his estimation they were impractical and the plans submitted would in no way alleviate the traffic problem at South 38th Street. Dr. Humiston nquired as to the status of 40th Street, since it was blacktopped by Mr. Gratzer. r. Backstrom replied that it is a city street, but was not graded according to city medifications and it has no curbs and gutters, and that the grade is dangerous. city can barricade the street if it is dangerous, he added. If an accident ocurs on this street because the grade is too steep, Mr. Boyle advised, in reply a question from Mr. Perdue, that the City would be held liable, and that Mr. ratzer might also be held liable. Mr. Marshall Riconoscuito, a member of the Plannmg Commission explained the history of the 40th Street situation, and pointed out that a year ago the Public Works Department and the City Planning Commission had recommended the vacation be granted, and he felt in order to justify the present reversal in recommendation, definite explanation and reasons should be given and lans for the use of the street should be submitted. Dr. Humiston said he was ready to vote on the question, and moved that the petition of A. F. Gratzer for vacation f South 40th Street from South Union Avenue to South Tacoma Way be denied. Motion seconded by Mr. Stojack and carried on roll call: Ayes 7; Battin, Goering, Hooker, umiston, Perdue, Stojack, Tollefson; Nays 2; Bratrud, and Jensen (not voting). absent O. Mr. Backstrom then asked for Council's instructions on the next step.  $\Delta f$  ter a discussion, the Mayor suggested that Mr. Backstrom meet with Mr. Gratzer and endeavor to iron out the difficulty and them make a report to the Council of the solution.

Upon motion, duly seconded and Carried, Council then adjourned at 9:25
