CITY COUNCIL MINUTES

City Council Chambers, 4:00 P. M. Tuesday, June 14, 1966

Council met in regular session. Present on roll call 9: Bott, Cvitanich, Finnigan, Haley, Herrmann, Johnson, Murtland, Price and Mayor Tollefson.

Dr. Herrmann moved that the minutes of the meeting of May 31, 1966 be approved as submitted. Seconded by Mr. Haley. Voice vote taken. Motion carried.

HEARINGS & APPEALS:

a. This is the date set for hearing on the petition submitted by Charles E. DeLauro requesting the rezoning of property located at the east side of Pacific Ave. and south of So. 88th St. extended, from an "R-2" to an "R-4-L" District.

No protests being made, Mrs. Price moved to concur in the recommendation of the Planning Commission and that a proper ordinance be drafted approving the rezone. Seconded by Mr. Murtland. Voice vote taken. Motion carried.

b. This is the date set for hearing on the petition submitted by Safeway Stores, Inc. requesting the rezoning of property on the N. E. corner of No. Proctor & No. 24th Sts. from an "R-2" to a "C-1" District.

No protests being made, Mr. Finnigan moved to concur in the recommendation of the Planning Commission and that a proper ordinance be drafted approving the rezone. Seconded by Mr. Cvitanich. Voice vote taken. Motion carried.

c. This is the date set for hearing on the petition submitted by E. Albert Morrison requesting the rezoning of property located in the vicnity of No. 26th St. and Narrows Drive from an "R-1" to an "R-4-L" District.

Mr. Morrison, petitioner, stated that the demand for apartment houses has exceeded the supply and he had not been able to buy vacant property already zoned for apartments in another section of the city. He asked Mr. Paul Lanske who works for the Post Engineers at Ft. Lewis to inform the Council of their problems in this regard.

Mr. Lanske stated, the influx of some 3,000 families, in connection with the formation of a training cadre at North Ft. Lewis, has created a housing problem. He felt there were probably vacancies in Tacoma, but their people were not finding adequate rentals for their various grades of pay.

Mr. Morrison also played a recorded message from an official of the

Boeing Co. who commented on the need for rental units.

Mr. Finnigan felt that this site was the wrong place to be starting this type of structure and predicted it would set a precedent for further apartment zoning along the street. Furthermore, the property across the street has already been zoned for "R-4-L", he added.

Mr. Haley felt there was ample vacant property already zoned for apartments and the Council should not rezone indiscriminately since this

would be abandoning sound zoning practices.

After further discussion, Mrs. Price moved to concur in the recommendation of the Planning Commission and that a proper ordinance be drafted approving the rezone. Seconded by Mr. Johnson. Roll call was taken on the motion, resulting as follows: Ayes 6; Nays 3, Cvitanich, Finnigan and Haley; Absent 0, Motion carried.
