CITY COUNCIL MINUTES

City Council Chambers, 4:00 P. M. Tuesday, January 19, 1965

1:0

Council met in regular session. Present on roll call 9: Bott, Cvitanich, Finnigan, Haley, Herrmann, Johnson, Murtland, Price and Mayor Tollefson. Absent 0.

Mr. Haley moved that the minutes of the meeting of January 5, 1965 be approved as submitted. Seconded by Mr. Finnigan. Voice vote taken, Motion carried.

HEARINGS & APPEALS:

a. This is the date set for hearing on the vacation submitted by the Public Works Dept. for the vacation of a portion of Ruston Way near Orchard St. extended.

No one appearing and no protests being made, Mr. Murtland moved that the proper Ordinance be drawn approving the vacation. Seconded by Mr. Haley. Voice vote taken. Motion carried.

b. This is the date set for hearing on the resoning of property submitted by <u>Tacoma Realty Inc.</u> for the resoning of property located at the south side of 6th Ave. from Trafton to Sieele St. from a "C-2" & "C-4" to a "C-1" District,

No one appearing and no protests being made, Mr. Finnigan moved to concur in the recommendation of the Planning Commission and that a proper ordinance be drawn approving the resone. Seconded by Mr. Bott. Voice vote taken. Motion carried.

- c. This is the date set for hearing on the petition submitted by the Planning Commission for Zoning Ordinance Text Amendments.
- Mr. Bott asked for an explanation of packaging in the "C-2" commercial district.
- Mr. Buehler, Director of Planning, stated, at present cosmetic packaging is only permitted in the "M-1" District. This change will permit packaging only in the "C-2" District.

No one appearing and no protests being made, Mr. Haley moved to concur in the recommendation of the Planning Commission and that a proper ordinance be drawn approving the Zoning Ordinance Text Amendments. Seconded by Mr. Bott. Voice vote taken. Motion carried.

d. This is the date set for hearing on the approval of Park Lane Plat

on "G" St. extended and Tacoma Ave. from So. 94th to So. 96th St.

Mr. Buehler said the reason this preliminary plat is brought before the City Council is because some objections have been made, but the Planning Commission recommended this plat over the objections of the abutting property owners. He added, before the developer goes to the expense of surveying the property for a final plat, it was felt that this matter should be presented to the City Council so the Council would be informed of the matter. He further stated the plat is located at South Park Avenue between So. 94th and So. 96th Streets. They propose an 18-lot subdivision on a five acre tract with a north-south street down the center of the site to serve the proposed subdivision. Access to be provided for the adjoining property, which would be landlocked, has been considered thoroughly, and meetings have been held to try to solve the problem.

Dr. Herrmann said, regardless of the disposition of this plat, those properties would not be affected one way or another with the approval or disapproval of this plat.

Mr. Buehler stated a strest pattern would have to be worked out to give access to the properties. This has been a problem area to try to come up with a development and still service all of the properties. An alternative would be to use the proposed deep-lot Ordinance so they would have private easements to serve their properties if agreed upon by the individuals concerned, he added.

Mr. Brinker, 9429 Park Ave., said the plat with the street in the center would make his property land-locked.

Mr. Wire, 9423 So. Park, stated he was in favor of the development but was opposed to the plat as he would realize a loss of his own building sites as the rear of his property is not on a street.

Mr. Buehler stated that an alternative street plan had been proposed by the Planning Dept., however, it did not meet the approval of the Federal Housing Administration.

Mr. Hill, property owner at So. 94th, said his home blocked off Tacoma Avenue, preventing a street from going through and Mr. Uhron's home at So. 96 St. is also in the same position. He stated he was opposed to the Park Lane Plat but was in favor of the alternative street plan as proposed by the Planning Staff.

Mayor Tollefson asked, Mr. Fred Lawrence, Engineer of the Development, if they had discussed this plat with the adjoining property owners in reference to the possibility of a plan whereby they would participate so they would not be land-locked, recognizing that they may have to give up a building site.

Mr. Lawrence stated that Mr. Morris, the developer and himself talked with the property owners and the only plan they approve is the cul-de-sac which does not conform with FHA standards.

Following a discussion by the City Council regarding the road access to the properties which would also be in agreement with the developer, Mayor Tollefson suggested that the matter be postponed for two weeks to see if something could be worked out agreeable to all concerned.

Mr. Bott moved to postpone the matter until February 2, 1965. Seconded by Mr. Johnson. Voice vote taken. Motion carried.

Ordinance No. 17755

Providing for the improvement of L I D 4744 for paving on No. 21st St. from Stevens to Proctor St.

Mayor Tollefson asked Mr. Schuster, Director of Public Works, to point out the areas under discussion on North 21st Street.

Mr. Schuster explained that the two areas in the district are located on North 21st St. from Proctor to Stevens and from Huson to Shirley St. and that the improvement provides for permanent type paving, including curbs, gutters and storm drainage. He also noted that property owners have contributed to L I D's for the paving of the other portions of North 21st St. from Union Ave. to Narrows Drive. He added \$176,000 is the estimated cost of the project. Approximately \$149,000 will be paid by bond funds and with 1/2 cent arterial gas tax money. Approximately \$27,000 will be assessed to the property owners.

Mr. Schuster continued, that the cost of an oil-mat surface on the street

with minimum drainage but with no curbs or gutters will be approximately \$102,000., however, this type of an improvement will not be assessed to the property owners. He said the amount of percentage filed against the district is 71.9% which pertains to the cost assessed to private property owners.

Mr. Haley asked Mr. McCormick, City Attorney, to explain the sone and termini method of assessment.

Mr. McCormick explained that the formula calls for the assessment area to be divided into 30 foot rones back in depth. The property further back from the improvement is assessed less per square foot.

The following property owners were present protesting the improvement Fred Carlbom, Robert Ward, Robert Walters, Mrs. Schweitzer, Mary Paugh, Jack Fabulich, Andy Berg, Lloyd Rivers and Gary Haines.

Mayor Tollefson explained the procedure on past L I D policies and also the development of the City arterials. He stated, under the State law the percentage of protests needed to automatically kill an L I D are to be based on the total cost of the project. He said in this improvement the City is contributing approximately 80% toward the paving, therefore, the Council could overrule the property owners' objections even if the percentage reached 100%.

Mr. Finnigan said he appreciated the feelings of the residents but the City is trying to develop a better traffic pattern throughout the City, which should be considered very strongly. It was contended by some of the property owners that the 1962 bond funds had included an oil-mat surface for 21st Street.

Mr. McCormick stated the official bond proposition listed no specific projects. It was left to the Council's descretion on how the bonds were to be spent.

Dr. Herrmann said he thought the Council should follow its previous policy of considering protest percentages as based on the total amount of the property involved rather than the total cost.

Roll call was taken on the Ordinance resulting as follows:

Ayes 1; Nays 8; Bott, Cvitanich, Haley, Herrmann, Johnson, Murtland, Price and Mayor Tollefson.

The Ordinance was declared LOST by the Chairman.

Mayor Tollefson stated that an oil-mat surface will probably be put in 129 on No. 21st St. if the City Council decides that it should go through as a part of the system.

In answer to a question, Mayor Tollefson explained that this decision by the Council does not set a policy but does set a precedent.

Mr. Haley asked that the Legal Dept. submit a written opinion regarding the procedure used in computing the percentage of protests of assessments having to do with the zone and termini method.

Mr. Cvitanich requested that a graphic map be submitted to the L I D Committee at their meetings so as to show the zone and termini method.

Mr. Rowlands said he would have a report compiled by the Staff with recommendations on future L I D policies on arterial streets.

Mr. Haley also asked that the Committee be informed of the percentage of contributions made as well as the total percentages against the property.
