# FIRST READING OF ORDINANCES:

Ordinance No. 19724

Amending Chapter 1.30 of the Official Code relative to Retirement and Pensions and declaring an emergency making necessary the passage of the ordinance and its taking effect immediately on publication.

Esther Campbell, Retirement System Manager, reviewed the formulas for retirement and answered questions of the Council.

The Ordinance was set over for final reading next week.

Ordinance No. 19725

Appropriating the sum of \$86,500.00 or so much thereof as may be necessary from the General Fund for the purpose of paying the City's share of operation of the County-City Health Department.

Earl Mittelstaedt, Finance Director, reviewed for Council the formula under which the County-City Public Health Pooling Fund operates. In addition to the funds provided for in the 1972 Budget, the \$86,500.00 is needed to cover the City's 50 percent share for operating the Public Health Department for the calendar year 1972.

The Ordinance was set over for final reading next week.

Ordinance No. 19726 Appropriating the sum of \$3,684,000 or so much thereof as may be necessary from the Federal Shared Revenue Fund for transfer to various operating funds and declaring an emergency.

Mr. Mittelstaed reviewed all of the items in the various funds for which the revenue sharing funds will be appropriated under this ordinance.

Mayor Johnston recommended that the City keep the United States Senators and Representatives apprised of the City's spending of the revenue sharing monies.

The Ordinance was set over for final reading next week.

# City Council Minutes - Page 5 - December 19, 1972

# Ordinance No. 19727 Adopting the Annual Budget of the City of Tacoma for the fiscal year 1973.

Bill Donaldson, City Manager, advised that the changes in the Preliminary Budget which Council requested be made are reflected in this Ordinance.

Mr. Jim Reed, Chairman of the Minority Concerned Task Force, inquired as to whether this was the proper time to make a request for the \$15,000 appropriation for the study of the Park Department. He was advised that this was not the time.

The Ordinance was set over for final reading next week.

Ordinance No. 19728 Amending the pay and compensation plan effective January 1, 1973 and declaring an emergency.

Odd Lund, Personnel Director, advised that a 5.5 percent increase across the Board is reflected on all positions of the City with the exception of 28 classes. Negotiations are still continuing with these groups; the issue not being the pay factor but working conditions. He advised that it is anticipated that by December 22, 1972 these problems will be resolved and the necessary amendments will be proposed to grant these classes a 5.5 percent salary increase.

The Ordinance was set over for final reading next week.

Ordinance No. 19729 Amending Section 1.12 of the Official Code relative to vacation and sick leave.

Odd Lund, Personnel Director, advised that the primary changes in the Pay and Compensation Plan reflected in this Ordinance are the method of computation of varation and sick leave hours to a bi-weekly figure rather than a monthly figure in order to computerize personnel vacation and sick leave hours. He advised there is no change in the allowance of sick leave and vacation hours, The Ordinance also sets forth the decrease in the hours of the fire service from 50 to 48 hours a week. It also provides for permissable use of sick leave for pregnancy.

The Ordinance was set over for final reading next week.

Repealing and reenacting Section 3 of Ordinance No. 15928 Ordinance No. 19730 as amended relative to Equipment Rental Fund Schedule of Charges.

Gilbert Schuster, Director of Public Works, advised that this Ordinance will adjust the schedule of charges in the equipment rental fund for City offices using motor vehicle equipment. The charges for the use of this equipment are being increased due to rising costs of equipment, depreciation, repairs and replacement.

The Ordinance was set over for final reading next week.

Mr. Moss moved to suspend the rules to consider a Resolution relative to the Park's resources and recreation. Seconded by Mr. Sonntag. Voice vote was taken and carried, with Mr. Nalley dissenting. 453

The Clerk read the proposed Resolution No. 22006.

The Resolution dealt with the appropriation of \$15,000 from the Contingency Fund for the purpose of a study to be conducted by an outside independent firm in the area of existing recreational and park facilities owned and operated by the various departments of City government and the Metropolitan Park District. Mr. Maule moved that the Resolution be adopted. Seconded by Mr. Moss. After discussion, Mr. Schroeder moved to continue the Resolution for one week in order that all citizens of Tacoma who wish to be heard could be present at the Council meeting to speak regarding the resolution. Seconded by Mr. Nalley. Voice vote was taken and carried.

The Resolution was continued for one week.

### REPORTS BY THE CITY MANAGER:

Bill Donaldson said that it was requested at the last joint City Council-Utility Board meeting that prior to the 1973 State Legislative Session another joint meeting be held. He suggested that a joint dinner meeting be held January 4, 1973 at the Utilities Department, together with the Legislative Team to review legislation which will be coming at the next Legislative Session.

\* \* \* \* \* \*

Mr. Donaldson also said that Council had directed him to arrange a public hearing concerning the refuse collection service in Northeast Tacoma. He advised that the hearing will be held Thursday, December 21, 1972 at 7 p.m. in the Brown's Foint Methodist Church at 5339 Brown's Point Boulevard N.E. In attendance will be representatives of the Legal Department, Refuse Utility and Health Departments. Council members were invited to attend.

Mr. Donaldson also commented on recent legislation to develop the Metropolitan Transit System in King County. He advised that one leg of the transportation system now serves the residents of Pierce County and a section of the City of Tacoma. There are presently 187 people making a round trip from Tacoma to Seattle on this Transit System. The City Council will be asked to provide for sharing of the deficit if any should occur on that route line. He said a Resolution will be brought to Council which will indicate the City's interest in continuing the service and an equitable financial arrangement.

## COMMENTS BY MEMBERS OF THE CITY COUNCIL:

Mr. Jarstad and Dr. Herrmann asked that the Manager have a representative from the Park Department or Board advise Council as to any existing studies, as they felt there already may be the kind of studies detailed in Resolution 22006.
