CITY COUNCIL MENUTES

City Council Chamberro, 4:00 P. M. Wednesday, Sopt 20, 1957

Council met in regular socsion. Precom on roll call & Finnigan, dorringen, Johnson, Murtland and Price: Absent & Bott, Cultanich, Heley and Mayor Tollofson. Mr. Bott arriving at 4:15 P. M.; Mr. Cultanich at 4:20 P. M. and Mayor Tollefoon at 4:25 P. M.

In the absence of Mayor Tollefson, Deputy Mayor Hearmann presided,

Mr. Johnson moved that the minutes of the meeting of Sept. 5, 1967 be approved as submitted. Seconded by Mrs. Price. Voice vote taken. Motion carried.

Mr. Paul Herlinger, Vice Pres. of the Civic Arts Commission, introduced Edward Seferian, Musical Director and Conductor of the UPS Tacoma Symphony.

Mr. Seferian explained that the annual program of free public concerts presently operates on a \$30,000 budget. The program involving participation of noted guest artists, is second to none among city concert series. He said they intend again this season to bring guest artists and make the concerts complimentary. He added, half of the orchestra's budget is received from community donations, with the remainder contributed by U P S. He asked the Uity Council to help in the amount of \$3500 because of the orchestra's increased leads for 1967 and 1963.

Deputy Mayor Herrinann thanked Mr. Horlinger and Mr. Saferian for Sisir presentations and assured them that the Council would take the request ander advisement.

Desentation of award to Mr. W. D. Trueblood.

Mr. Rowlands explained that Mr. Trueblood developed a unique cooling system in the Photo Lab and has won a \$25.00 award.

Deputy Mayor Herrmann presented Mr. Trueblood with the award. Mr. Trueblood was congratulated by Deputy Mayor Herrmann, Mr. Sowlands, City Manager, and members of the City Council.

b. This is the date set for hearing for the vacation of No. 48th between Les and Gove Streets, submitted by Mrs. Anthony Ukich.

Mrs. Price moved to concur in the recommendation of the Planning Commission to approve the vacation, and that an ordinance be drafted approving same. Seconded by Mr. Muriland. Voice vote taken. Motion carvied.

Mayor Tollefson arriving and assuming the Chair.

c. This is the date set for hearing on the appeal filed by James P. Healy et al on the denial of the request for rezoning of the west side of Pine St. between So. 45th & 47th Sts. from an "R-3" to an "R-3-T" District.

Mr. Buchler, Director of Planning, pointed out the property in question on the map, that is being appealed by the petitioner.

Mr. Healy, potitioner, explained that the erection of the Mall had worked a drastic change on the residential character of the neighborhood. When the Mall was developed they raised a forty-five foot high dirt bank on the east side of Pine Street, whereas before that wall was erected, the persons living in the homes affected by this patition had a beautiful view of Mt. Rainier. Now they have a view of a high bank. The bank is a great deal higher than the telephone poles, and these properties have lost their desirability as strictly residential properties.

Mr. Healy noted that four streets intersect with Pine St. between So. 38th and So. 48th. The first block is 100% commercial. The first block north of So. 48th is zoned "C-1" and it was anticipated that it would be developed into a commercial development. The first two houses north of So. 48th St. are zoned "C-1". He noted that the block between So. 45th and So. 47th St., bordering Pine St., is the only block which has an alley and it is the only block which can provide access for adequate off-street parking.

Mr. Healy felt that the granting of this petition would be der the public good and general welfare.

Mr. Finnigan asked if the petitioners were willing to pay for the complete construction of the alley.

Mr. Buehler stated this was not brought up at the Commission meeting.

Mr. Healy stated the majority of the petitioners live on the east side of Junett St. across the alley from the property in question; there had not been any mention of any alley improvement.

Mr. Johnson said he is in sympathy with the residents as he felt the construction of the Mall has ruined the area for residential purposes. He felt the request from the petitioner was reasonable.

After further discussion, Mr. Johnson moved to everrule the recommendation of the Planning Commission to deny this resone and that an ordinance be drafted approving same. Seconded by Mrs. Price. Noice vote taken. Motion carried.

Mix. Critanich asned, relative to the statue of the lights on No. 21st St. Mr. Rowlands stated the excipment has been ordered for some months now, and the contract has been let.

Mr. Murtland asked why some stop lights at certain times of the day change to amber and red at night. He asked what saving is accomplished by doing this. He felt the change was most confusing.

Mr. Schuster stated they were trying to obtain easier movement of traffic for evening hours. There is no savings to the City, only that the traffic is less.

Mrs. Price asked about a report on the traffic light on Junett & 6th Ave. Mr. Rowlands stated a recommendation has been made and will be forwarded to the Council next week.
