FIRST READING OF ORDINANCES;

Ordinance No. 19956

Appropriating \$20,499.00 or so much thereof as may be necessary from the Federal Shared Revenue Fund for the purpose of transferring said sum to Tacoma-Pierce County Health Department to expand the operation of the Poison Information Center.

Fred Pritchard, Administrator of the Mary Bridge Children's Hospital reviewed the program and answered questions for Council.

The Ordinance was set over for final reading next week.

Ordinance No. 19957

Approving the action of Tacoma-Pierce County Board of Health in appropriating \$8,298.00 of which the City will contribute 50% or the sum of \$4,149.00 for the purpose of carrying out a Senior Citizens Flu Immunization Program and authorizing a transfer of \$4,149.00 from the Contingency Fund to the General Fund for said purpose.

Brandon Gallagher, Director of the Pierce County Community Agency, reviewed the program and answered questions for Council.

It was suggested by Council members that other areas in the City be established for the flu shots in addition to the locations in the central area of the City.

The Ordinance was set over for final reading next week.

Ordinance No. 19958

Appropriating \$64,442.00 or so much thereof as may be necessary from the Federal Shared Revenue Fund for the purpose of transferring same to Tacoma Public Library to provide continuance of special library service to senior citizens.

Mary Frances Borden, Director of the Tacoma Public Library, reviewed the program and answered questions for Council and introduced the following individuals who spoke in favor of the Ordinance: Pat Tyler, Activity Director for three nursing homes; Marion Pardini, Activities Director for Bayview Terrace and Rest Haven; Royal Freeman, Administrator of Life Manor; Alma Dedeaux, Administrator of the Orchard Park Convalescence Center; Tony Passanante, 4406 North 11th Street.

The Ordinance was set over for final reading next week.

Ordinance No. 19959

Amending Chapter 6.89 of the Official Code by repealing and reenecting Sections 6.89.010 through 6.89.050 relative to bingo, raffle or amusement games and declaring an emergency making necessary the passage of this ordinance and its taking effect immediately upon publication.

Richard Newman, Assistant Tax & License Director, advised that his information to Council would cover this ordinance and the following two ordinances.

Ordinance No. 19960

Amending Chapter 8.100 of the Official Code by repealing and reenacting Sections 8.100.010 and 8.100.020 relative to gambling activities and declaring an emergency making necessary the passage of this ordinance and its taking effect immediately upon publication.

Ordinance No. 19961

Amending Chapter 8.12 of the Official Code by repealing and reenacting subsection 29 of Section 8.12.010 relative to gambling and declaring an emergency making necessary the passage of this ordinance and its taking effect immediately upon publication.

Mr. Newman advised that the changes in the City's gambling ordinances are required in order to comply with action taken by the State Legislature at their mini-session in September. Mr. Newman confirmed that the rules and regulations on gambling are established by the State Gambling Commission; however, gambling can be denied by the City.

On question of Mr. Sonntag, Mr. Donaldson advised that the County is considering a tax structure that would be over the five percent already established by the City.

Mayor Johnston advised that the County Commissioners had expressed a desire that the County and City have a uniform tax on gambling. He suggested that before final reading of the ordinances, a meeting with the County Commissioners be held regarding the uniform tax. He suggested that if a tax increase is to be considered on final reading, he would suspend the rules to permit citizens to speak. Mayor Johnston directed the City Manager to arrange for the joint meeting.

Mrs. Egan asked for an opinion from the Legal Department on the City's options regarding gambling.

Ordinance Nos. 19959, 19960 and 19961 were set over for final reading next week.

# COMMENTS BY MEMBERS OF THE CITY COUNCIL:

Mr. Sonntag referred to a complaint he had received from Margaret H. Thompson, 6332 North 26th, relative to lack of a crosswalk and requested the City Manager's Office to contact the lady regarding the complaint.

Mr. Nalley commented regarding operation of the Minority Contractors and requested answers concerning procedures from Mr. Althiemer and Mr. Palmquist. He felt that it would be appropriate to hold this discussion at a Study Session with Mr. Altheimer and Mr. Palmquist present.

Mayor Johnston commented that it has come to his attention that the dates in which first class cities can consider budgets has been revised by the legislature. He asked that consideration be given to moving the Public Hearing on the budget into November.

Mayor Johnston referred to a communication he received from Clyde B. Gifford, 1401 East 31st, regarding problems on the Eastside of the City. Mayor Johnston moved to suspend the rules to permit Mr. Gifford to be heard. Seconded by Mr. Sonntag. Voice vote was taken and carried.

Mr. Gifford, representing the parents of the Eastside Community, spoke of children being molested going to and from school and molesters hiding in the brush on City property. He requested the City clean the area and fence the walkways to and from the school and have patrols at each end of the fence. He also suggested a committee be formed to include at least one resident of the area to study and determine improvements and safety factors.

Mayor Johnston requested the City Manager, with the assistance of City departments as well as the School District, investigate and resolve the problem immediately.

Mr. Gifford presented a petition to the Mayor containing 149 signatures.

Mr. Nalley made a motion that Council ask the State Mediator to appreciate the urgency of the teachers and trustees regarding the strike at Tacoma Community College and do everything possible to settle the strike before the school quarter is cancelled. The motion failed for lack of a second.
