PUBLIC HEARINGS:

City Planning Director, Russell Buehler, reviewed the proposed text amendments pointing out the purpose of the changes is to clarify several ambiguous provisions of the Zoning Ordinance and to remove some other inconsistencies. He pointed out the proposed changes were approved by the Planning Commission 6-1, 2 absent.

Mrs. Egan moved that the changes be adopted. Seconded by Mr. Sonntag. Voice vote was taken and carried.

### FINAL READING OF ORDINANCES:

Ordinance No. 19688

( ....

(Continued from the meeting of February 27, 1973) Amending the Official Code by repealing Chapters 1.29 and 8.80 and reenacting Chapter 1.29 relative to creation of • Human Rights Commission.

In response to a question by Mayor Johnston, Assistant City Attorney Judd pointed out that the State Human Rights regulations are basically the same as those proposed in Ordinance 19688, differing only in administrative structure. He noted that the State Law is due to be broadened in scope and sustanance.

Councilman Nalley, who was Chairman of the Special Council-Human Relations Sub-Committee, reviewed the history of Ordinance 19688 since October, 1972, and briefly reviewed the results of his meetings of the Sub-Committee including the Special Statement Hearing of March 6, 1973.

Mr. Judd then was called upon to review the amandments proposed by the Joint Sub-Committee.

Mr. Judd pointed out that the proposed amendment adding a new section 1.29.130 regarding City Council review has already been approved by the Council, and that further discussion would be mute unless a further change was requested. There was no discussion. Mr. Judd then read into the record the following proposed amendment:

1.29.070 DUTIES AND POWERS. In addition to other powers and duties set forth in this ordinance, the commission shall have the power and duty to:

A. Study and investigate, mediate and hold public meetings on community-wide problems arising in the City of Tacoma which may result in intergroup tensions or discrimination on the basis of race, religion, color, ancestry, sex, age or place of birth. In the performance of its duites under this subsection, the commission may compel the attendance of any person whose testimony is relevant and reasonably necessary to its inquiry. The commission may further request in writing that the City Council compel the production of papers and things which are relevant and reasonably necessary to its inquiry and, upon such request, the City Council shall consider same and in its discretion may comply therewith. Any inquiry involving any agency, board or officer of the City of Tacoma shall be governed by the provisions of subsection E hereof.

Mr. Judd reviewed a third proposed amendment making changes to sub-section 1.29.100.A on pages 9 and 10 as follows:

"Add the word 'age' in subparagraphs #1 through #8 of said subsection."

"1.29.110 PENALTY FOR VIOLATION. Those practices defined as unfair discriminatory practices in this chapter are hereby declared to be unlawful. Every person convicted of a violation of any of the provisions of this chapter shall be guilty of a misdemeanor and shall be punished by a fine of not more than five hundred dollars or imprisonment for not more than ninety days, or both such fine and imprisonment. Every firm, corporation, agency or bureau of association convicted of a violation of any of the provisions of this chapter shall be guilty of a misdemeanor and shall be punished by a fine of not more than five hundred dollars or by imprisonment for not more than ninety days or both such fine and imprisonment."

Mr. Nalley made a motion, seconded by Mr. Moss, that Section 1.29.110 be amended.

"The commission is specifically authorized to make rules and regulations governing its organization and procedures which are not inconsistent with this chapter or any other chapter or section of the Official Code of the City of Tacoma. All regular and special meetings of the commission shall be held in strict accordance with and pursuant to any and all applicable State law as the same now exists or may hereafter be amended with respect to open and public meetings."

He said the program would be in two six-week increments and would be coordinated with the existing NYC Program.

Following a lengthy discussion, Mayor Johnston moved to continue first reading of the ordinance for two weeks to allow time for the suggested project to be raviewed by the Federal Task Force Team and make recommendations to the City Council. Seconded by Mr. Jarstad.

Mayor Johnston commended Councilman Nalley for his chairmanship of the Joint City Council-Human Relations Sub-Committee and the amendments brought in for consideration by the City Council.

Mayor Johnston appointed the L.I.D. Committee for March, April and May in the persons of Moss, Herrmann and Johnston.

Mayor Johnston acknowledged the letter from the Tacoma-Pierce County Civic Arts Commission in which the Commission requested the Council to amend its Arbor Ordinance to allow the City to function independent from the County in setting up an Arbor Committee.

Councilman Jarstad, who inquired about the Arts Commission, suggested the Council raview the request before taking any action.

Mayor Johnston acknowledged a letter from Douglas P. Atwood, attorney representing the Polynesia Apartments Grievance Committee seeking aid for the recent 22 percent increase imposed upon the renters by the governing corporation.

City Manager Donaldson stated that Mr. Atwood had contacted him and he related the information that the City had no legal way of assisting the renters, but did relate that he was successful in getting the renters'representatives together with corporation officials to discuss the problem and that hopefully they could work out some equitable solution.

Regarding the previous discussion on the Human Relations Ordinance 19688, Mr. Sonntag pointed out that many people are urging that the City adopt by reference the State Law on discrimination. He explained the difference between the State Law and the new City Ordinance, noting that the City Ordinance is more concilitory and adaptable for use within the City of Tacoma.

In response to a question by Councilman Jarstad, City Attorney Robert Hamilton, indicated that the State Legislature is considering amendments to the Open Meeting Law making it more workable, particularly revolving around possible exemptions for labor negotiations and social meetings of public budies.
