An ordinance to be known as the Plumbing Code; requiring a permit and the collection of fees therefor, for the installation or alteration of plumbing or drainage systems; defining certain terms; establishing minimum regulations for installation, alteration or repairs of plumbing and drainage systems and the inspection thereof; providing penalties for the violation thereof; adopting by reference a Uniform Plumbing Code as amended; repealing Ordinance No. 11652 and all amendments thereto and all parts of ordinances in conflict with this ordinance; and specifying the effective date hereof. Read by title and placed in order of final reading. Mr. Backstrom explained that this is one of the ordinances which it is desirable to bring up to date prior to January 1, 1956, after which time the Charter requires that a compilation of ordinances be published. The Air Pollution ordinance and the Traffic Code are also in the process of revision, he stated, and it was felt it would be best to bring these revisions before Council at regular intervals in order to allow time for consideration and a hearing if necessary. He suggested that a hearing be held on the new Plumbing Code next Monday, January 17th, which was agreeable to the Council.

Amending Sections 15, 17, 18, 20, 28, 30, 31, 32, 33, 34 and 50 of Ordinance No. 15106 entitled: "An ordinance adopting the pay or compensation plan as contemplated by Section 6.9 of the City Charter; prescribing the salaries to be paid to nonelective officers and employees of the City; establishing the positions of the various departments of the City government; fixing the effective date of this ordinance, etc." Read by title and placed in order of final reading. As Mr. Barline was present, Mr. Backstrom called upon him to explain to the Council the changes being made by the amendment as they pertained to the Utilities Department. Mr. Backstrom then explained what changes were being made in the General Fund departments and the reasons for making same. Section 39 of the original ordinance was over-looked in this revision to change the daily wages paid certain employes in the Fire Alarm Division of the Fire department, he said, and he submitted a copy of the new schedule for each council member's information. It was moved by Dr. Humiston, seconded by Mr. Jensen that Ordinance #15220 be amended before final reading by the addition of Section 12,

which will amend Section 39 of the Compensation plan to commide with the revision submitted by the Manager. Motion carried unanimously.

FINAL READING OF ORDINANCES:

Ordinance No. 15208.

Vacating the alley between Cedar and Junett Streets extending from South Tacoma Way on the south to Northern Pacific Railroad right of way on the north, being the alley between Blocks 11 and 12 of Junett's Addition; and a narrow strip of land extending between Cedar and Junett Streets along north side of Blocks 11 and 12 and between Northern Pacific Railroad right of way and Lots 1 and 2, Block 12, and Lots 1, 2 and 3, Block 11, Junett's Addition. It was moved by Dr. Humiston to suspend Rule 9, seconded by Mr. Perdue and carried unanimously on voice vote. The ordinance was then passed without having been read in full.

Repealing Ordinance No. 11262 entitled: "An ordinance creating a special fund to be known as the Garbage and Refuse Department Reserve Fund out of the surplus revenues of the Garbage and Refuse Department, and prescribing the purposes for which said fund may be used." and providing for the disposition of any moneys in said fund. Read in full; and passed.

Ofdinance No. 15210.

Amending Section 5 of Ordinance No. 10005 entitled: "An ordinance relating to health and sanitation; providing for and regulating the collection, removal and "but disposal of garbage and refuse and dead animals in the City of Tacoma; providing for the handling thereof exclusively by the City through its Garbage and Refuse Department; providing penalties for the violation hereof, etc." and declaring the effective date hereof. Read by title. It was moved by Dr. Humiston, seconded by Mr. Perdue to suspend Rule 9 and carried unanimously on voice vote. Mr. Backstrom advised that his report, M. C. #63, dated December 20th, 1954, suggesting raise in Garbage rates, had been carefully rechecked this past week, and it appears that by taking into consideration certain economies made possible by elimination of two positions, elimination of Saturday overtime pay, and inauguration of bi-monthly billing the department could operate under the 90¢ rate (a 20% increase in charges) and at the same time replace some equipment. A re-examination of the Department should be had at Budget time next October, he added, to ascertain whether the rates should continue or be increased to \$1.00 (33-1/3%) However the most conservative precedure would be to increase the rates now 33-1/3% and if circumstances warrant a free month of service could be granted at the end of the year, Mr. Backstrom said.

The two suggested rates were discussed at length, some of the Council members favoring the 20% increase and some the 33-1/3%. The Director of Finance stressed the financial need of the Garbage Department, saying that there is immediate need for funds to take care of a delinquent State Tax amounting to approximately \$21,000 as soon as possible, and added that the 20% increase would leave a very tight budget for the Department's operations. Col. Hooker, Mr. Bratrud and Dr. Humiston said they were willing to go along with the Manager's suggestion that a 20% increase be tested for one year, but Dr. Battin said he was definitely opposed to this plan. Mr. Backstrom said he had Ordinance No. 15210 re-written on the 20% increase plan and he furnished each Council-man with a copy of the new ordinance. It was moved by Mr. Jensen, seconded by Dr. Humiston to substitute the new ordinance based on a 20% increase

This being the date to which Council continued the hearing on application of Sity of Tacoma, Water Department, for vacation of a certain portion of East N Street 4/9 at or near 37th Street, which is necessary for the construction of a low service reservoir, the Clerk read a communication from Kenneth O. Wilcox, Chief Planning Engineer, advising the City Planning Commission at its meeting of January 4, 1955, recommended approval of the vacation subject to the Public Utilities Department dedicating at Sauchitime as required for street purposes that portion of the tract owned by the Water Division and lying westerly of a straight line connecting the easterly boundary of East MMM Street to East 38th Street. Moved by Dr. Humiston to concur in the recommendation of the City Planning Commission and grant the request for the vacation of the property as requested by the Water Department. Motion seconded by Mr. Perdue and carried on roll call: Ayes 8; Nays 0; Absent 1; Stojack.

The L. I. D. Committee reported that hearing was held by the Committee on L. I. D. 4548 on January 3, 1955 for concrete paving and curbs on South 46th Street from Park Avenue to South G Street, and at said meeting it was reported that a remonstrance of 62.8% had been filed against the improvement. In view of this large remonstrance, the L I D Committee sustained the remonstrance and ordered that the district be abandoned, and makes this recommendation to the Council. It was moved by

NEW BUS INESS:

Mr. Backstrom presented M.C. #66- which he had prepared at the request of Cpuncilman Hooker, on the subject of the City Hall Chimes. The question would be whether the City Council wished to move the old chimes to the new County-City Building, which would cost nearly \$4000 including installation of new electric strikers, or install new modern chimes for \$2,500.00. The report stated also that the cost of the electronic chimes could be covered if the old bells were turned in on the modern electronic sound device. The report was discussed, and it was pointed out by Mr. Bratrud that the final decision was up to the County Commissioners. It was moved by Mr. Jensen that the report be adopted and a copy be referred to the County Commissioners for consideration. Motion seconded by Mr. Bratrud and carried on roll call: Ayes 7; Nays 1, Battin; Absent 1; Stojack.
