City Council Chambers October 21, 1975

The meeting was called to order at 5:06 p.m.

Based on the request, Mr. Sonntag made a motion to remove the item from the agenda. Seconded by Mr. Warnick. Voice vote was taken and carried.

b. This is the date set for hearing the appeal of Connie Schick, Inc. and Conrad P. Schick, formerly d/b/a Custom Floor Covering on the Business and Occupation Tax assessment by the Tax & License Department.

Deputy Mayor Hermann advised Council that Attorney George W. Christnacht has filed a letter with the Council requesting a two week delay in hearing the appeal because the attorney representing Mr. and Mrs. Schick was forced to leave the State on a business trip.

Mr. Nelson moved to postpone action on the appeal for two weeks, seconded by Dr. Herrmann & refer the entire matter to the hearings examiner for hearing and recommendation to the Council. Following additional discussion, however, Mr. Nelson, with permission of his second, withdrew his motion, which was followed by a motion from Mr. Sonntag to continue the appeal for two weeks. Seconded by Mr. Nelson. Voice vote was taken and carried.
