Mayor Johnston moved to amend the Resolution to include Mr. Backstein's recommendation that Council flag the testimony given on the street vacation in part B. Seconded by Mr. Warnick. Voice vote was taken and carried.

Resolution No. 23843 Authorizing execution of a contractual agreement with Conifer Developments, Inc. relating to an "R-3PRD" low density multiple family planned residential development district located on the northwest corner of South 76th and Wilkeson Streets.
