Councilman Rasmussen moved to table Resolution No. 26996 and moved that we accept and implement the recommendations made by Ed Wundram, outlined in his June 5, 1981 memo to Erling Mork, entitled "1% for Art," with two additions in the area of the advisory panel. One, that the panel include one Councilmember and two, that members of this panel be nominated by City Staff to be confirmed by City Council. Seconded by Councilman Sutherland. Voice vote was taken and carried with respect to tabling the resolution.

Roll call vote was taken on the motion to accept recommendations made by Ed Wundram, resulting as follows: Ayes: 6 - Bichsel, Hawkins, Hyde, Rasmussen, Sutherland and Mayor Parker. Nays: 3 - Kirby, Nielsen and Strege. The motion was declared carried.

Final reading of the Ordinance was set over to June 30, 1981.

Authorizing execution of a contract with the Fourth of July Extravaganza and Military Pageant Commission to perform certain services relative to the Fourth of July celebration.

Councilman Hyde moved that the Resolution be adopted. Seconded by Councilwoman Bichsel. Voice vote was taken and carried. The Resolution was declared adopted.

Councilman Hyde moved to suspend the rules to consider Resolution No. 27012. Seconded by Councilman Rasmussen. Voice vote was taken and carried.

Authorizing execution of an agreement between the City and Tacoma Public School District #10 in the amount of \$7,081 to provide career development work experience classes for eligible City youths participating in Summer Youth Employment Program.

Councilman Rasmussen moved that the Resolution be adopted. Seconded by Councilwoman Bichsel. Voice vote was taken and carried with Councilman. Hyde abstaining. The Resolution was declared adopted.

UNFINISHED BUSINESS:

Councilwoman Bichsel moved that the City Council strongly urge the Utility Board, the City's representative to the WPPSS Executive Committee, and Participants' Committee to support the moratorium on construction on projects #4 and #5 as recommended by the Executive Director of WPPSS,. Robert Ferguson. Seconded by Councilman Hyde. Voice vote was taken and carried. The motion was adopted.

REPORTS BY THE CITY MANAGER:

City Manager, Erling Mork, advised the Council that they can cancel the Council meetings of August 4 and 11, 1981. After discussion by the Council it was unanimously agreed upon to cancel the meetings for those two nights.

COMMENTS AND COMMITTEE REPORTS BY MEMBERS OF THE CITY COUNCIL:

Councilman Hyde asked to be excused from the Council meeting of June 30, 1981. Voice vote was taken and carried. Councilman Hyde is excused from the Council meeting of June 30, 1981.

Deputy Mayor Nielsen moved to recess into Executive Session to discuss matters relating to litigation. Seconded by Councilman Sutherland. Voice vote was taken and carried. Council recessed at 8:30 p.m. and reconvened at 8:40 p.m.

Deputy Mayor Nielsen moved that the City Attorney be given the authority to settle the claims involving Carlson and Deerback as explained to the Council at Executive Session. Seconded by Councilman Rasmussen. Voice vote was taken and carried.

On proper motion, the meeting adjourned at 8:41 p.m.
