Expressing the intent of the City Council to hold a joint City Council/Public Utility Board public hearing on the issue of making termination payments for Washington Public Power Supply System Nuclear Power Plants Nos. 4 and 5.

Mayor Sutherland moved to consider Resolution 27825 subsequent to the Executive Session when this matter would be discussed. Seconded by Councilman Rasmussen. Voice vote was taken and carried. The motion was declared adopted.

PUBLIC HEARINGS AND APPEALS:

This is the date set for hearing the appeal of Bruce Brown, Jr., regarding the denial by the Hearings Examiner of his request for reconsideration and of his application for the reclassification of the southeast corner of South 48th and Oakes Streets from an "R-2" to a "C-2" District.

Hearings Examiner, Robert Backstein, made a presentation regarding the appeal.

As Bruce Brown had not appeared, Mayor Sutherland moved to consider the appeal subsequent to Executive Session. Seconded by Councilman Ladenburg. Voice vote was taken and carried. The motion was declared adopted.

Mayor Sutherland moved to recess until the arrival of Mr. Malanca, at which time the Council would go into Executive Session for purposes of discussing litigation. Seconded by Councilman Rasmussen. Voice vote was taken and carried. The motion was declared adopted. Council recessed at 5:56 p.m., went into Executive Session at 6:03 p.m., and reconvened at 6:55 p.m.

Mayor Sutherland announced that the Council would consider the appeal.

Mr. Bruce Brown, Jr., discussed the reason for his appeal.

Mr. Gerald Van Noy, 7232 South Montgomery, representing the neighbors in the area, discussed why the neighborhood was opposed to Mr. Brown's request.

Substitute Resolution No. 27825 was read into the record:

"BY REQUEST OF LADENBURG

WHEREAS there has been much controversy regarding termination payments on Washington Public Power Supply System Nuclear Power Plants Nos. 4 and 5. and

WHEREAS the Public Utilities Light Division has reserved sufficient

funds for the first payments of such debt from its 1983 budget, and

WHEREAS it is advisable that citizens be allowed to discuss the issue of termination payments before actual payment is made; Now, Therefore, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TACOMA:

That the Council of the City of Tacoma does hereby express its intent to decide said issue in a public meeting where citizens will be allowed to express their opinions on the issue of WPPSS payments."

Mayor Sutherland indicated that discussion on whether to make any payment to WPPSS would most likely be held at the regular City Council meeting on April 19, 1983.

Councilman Ladenburg indicated that because of discussions in the Executive Session the Council anticipates changes in the next few days, due to resolution of court matters regarding WPPSS payments. A meaningful discussion of this matter would not be possible until next week.

Councilman Strege commented on the policy that City funds not be used on subsidized, out-of-City Water projects. Clarification from the Water Division was reguested on this matter.

Mayor Sutherland stated that there would be a public hearing on April 14, 1983, at 9:30 a.m. in the Council chambers, conducted by the Puget Sound Air Pollution Control Agency. The subject will be the difficulties of non-attainment of air pollution requirements in the City of Tacoma.
