#### Ordinance No. 27321

Amending Chapter 13.17 of the Municipal Code, relating to Mixed-Use Center Development, to offset the costs of administration of the 10-year Property Tax Exemption program by increasing the fees for approved applications for up to four multi-family units to \$1,000, with an additional fee of \$100 per multi-family unit, up to a maximum fee of \$5,000, effective April 1, 2005.

#### COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Council Member Evans thanked the organizers of the Wintergrass blues festival for bringing their incredible event to Tacoma. He also mentioned that Gunsan, South Korea, would be highlighted at the upcoming Film and Food Festival night at the Blue Mouse Theatre and thanked Ms. Debra King, Sister Cities Program Coordinator, for her efforts in organizing the film series.

Council Member Talbert mentioned public safety and improving the quality of life were on the agenda for the Eastside Action Team community meeting that night. He stated he would be reading at Lyon Elementary School the next day in recognition of "Read Across America Day." He also mentioned an upcoming Literacy Event on Friday, March 4, 2005, to be held at the Portland Avenue Community Center. He briefly commented on the letter he received from the Tacoma Housing Authority (THA) stating that THA did not need to use the funds offered by the City for the Section 8 program. He stated Senator Maria Cantwell's office notified him that a grant of \$83,000 had been approved to study the barriers to development on the lower East Side and that he was looking forward to working with the Economic Development Department and the partners on the East Side.

Council Member Lonergan commented on information received from the National Community Development Association announcing that due to the collective efforts of cities and other organizations around the country, a majority of United States Senators are now in support of continuing the Community Development Block Grant Funding Program.

Council Member Manthou stated that the Class 3A State High School Basketball Championship was being held at the Tacoma Dome this week and the Class 4A tournament will be held next week. He reported the City Manager recruitment period ended last week with a total of 37 applications received. He added the consultants were pleased with the exciting, highly qualified group of applicants He expected the final selection to be made by the end of March.

Council Member Anderson stated she had anticipated the Teamsters Local 117 labor contract to be on the agenda and asked that it be placed on the agenda for the March 8<sup>th</sup> Council meeting.

Deputy Mayor Ladenburg thanked the Sea Scouts for participating in the meeting. She announced a Park Patrol Open House on March 15th which will be held at 4702 South 19<sup>th</sup> Street.

Mayor Baarsma expressed pride and enthusiasm in the accomplishments of the University of Puget Sound (UPS) basketball team finishing the season with a 21-3 record, winning the Northwest Conference for the second year in a row with a 15-1 record. He stated UPS was selected to be the western regional host for the playoffs this Saturday and wished them well. He mentioned Mr. Marv Scott, a coach and teacher at both Stadium and Wilson high schools, had passed away this week. He expressed his condolences to the family.
