REPORTS BY CITY MANAGER

City Manager James Walton expressed his appreciation to the Mayor, Council, and citizens of Tacoma for their expression of trust and support in passing the Resolution making him the interim City Manager. He stated his role would be to maintain focus and keep the team together as they work through this difficult period of time.

Mr. Walton announced that Tacoma Economic Development Director Juli Wilkerson has been chosen to receive the Singular Exemplary Achievement Award from the Evergreen Chapter of the American Society for Public Administrators, which recognizes an individual who has achieved exceptional public service accomplishments within the last two years. He thanked Ms. Wilkerson and her staff.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Council Member Talbert stated it has been ten days since this horrific act of murder was committed. He stated it is human nature for rational thinking people to attempt to somehow rationalize this unbelievable act and that in doing so we automatically look for someone or something to blame. He stated David Brame is responsible for the murder of his wife, the devastation of two families, and for placing his children in a position no child should ever have to deal with. He stated we must learn from this tragedy and other communities must benefit from what we learn. He stated it is important that the investigation be allowed to be completed so that the conclusions can be provided to the Council, which has the responsibility of correcting areas of deficiencies and, if it is proven that individuals were derelict in their duties, to take appropriate action. He stated that coming out of this horrific event, it would be an even bigger tragedy if we failed to learn from this, and if we failed as a community to educate others about what we learned. He encouraged everyone to come together to help heal the community and ensure that no spouse of a public safety employee ever be made to feel there is nowhere to turn for help.

Council Member Lonergan congratulated Senior Airman Terri Rollins for receiving the 22nd Annual Howard O. Scott Citizen-Soldier of the Year award from the Tacoma-Pierce County Chamber of Commerce during a recent luncheon at the Kiwanis Club.

Council Member Lonergan commended the officers and non-commissioned staff of the Police Department for carrying on in protecting our City during this tragic time. He commended the various domestic violence agencies within the community for responding to a very large number of requests for assistance and information during the past week. He stated many people have come together in prayer for Crystal's and David's families and for the City of Tacoma.

Council Member Ladenburg stated this Saturday, from 1 p.m. to 4 p.m., at Wright Park, there will be a time for community healing. She stated the Pierce County Commission Against Domestic Violence is sponsoring a remembrance and vigil for Crystal Brame, her family, and victims and survivors of domestic violence.

Mayor Baarsma stated there has been no historical parallel to the nightmare this community has endured. He thanked Council Member Talbert for his comments, which represent the sentiments of the Council. He then thanked his Council colleagues for doing the right thing this evening in the Resolutions which were considered to restore faith and confidence in our government.

Council Member Evans thanked his Council colleagues for their comments in relation to the tragedy our community has suffered. He commended the citizens for their testimonies tonight. He stated this is democracy in action. He stated he received many calls from television stations, radio stations, and newspapers. He stated a writer from the *Seattle Post Intelligencer* called Sunday and asked if nothing good was happening in Tacoma. He said he then realized that 7,000 people in our City last weekend joined in the opening of the museum. He stated 1,300 people attended the tour of historic homes over the weekend. He stated the Associated Ministries Banquet was attended by 600 people. He stated this shows there are lots of good things happening in Tacoma. He stated we will conquer this horrendous tragedy.
