a. <u>Jonathon Chaffey and Gloria Hartley representing various neighbors</u> appealing the recommendation of the Hearing Examiner on the request to vacate a portion of North 38th Street, west of Washington Street, to include the vacated property as additional yard space. (Noble & Driessnack; File No. 124.1061) (Continued from the meeting of May 5, 1998.)

Council Member Baarsma stated that the property involved in this matter is in his neighborhood. He stated that he felt that all parties should feel that the process be impartial and that there be an appearance of fairness. He stated that he feels that it is proper and appropriate for him to recuse himself.

Mayor Ebersole stated that a quasi-judicial appeal hearing was held on May 5, 1998. He stated that Deputy Mayor Crowley and Council Members McGavick and Miller were not in attendance at the hearing but have been provided with a copy of the video tape of that portion of the City Council meeting. Mayor Ebersole then asked for Council Member comments.

Council Member Miller stated that he was provided with copies of the video tape. He stated that this is a quasi-judicial hearing. He stated that he felt it would be difficult for him to rule properly without having substantial legal questions answered by the Hearing Examiner who is not in attendance at this quasi-judicial hearing. Council Member Miller then recused himself from the appeal hearing.

Council Member Kirby moved to overrule the Hearing Examiner and uphold the appeal and to direct the City Attorney to draft Findings of Fact and Conclusions of Law in keeping with the Council's Decision to be presented for adoption at the next City Council meeting. Seconded by Council Member McGavick.

REPORTS BY CITY MANAGER

City Manager Ray E. Corpuz Jr. stated that there has been a County-wide effort to have implemented trauma service for the City of Tacoma and Pierce County. He stated that a decision has been made by local physicians and hospitals regarding an operating budget and implementation of a Level 2 trauma service. Mr. Corpuz stated that the implementation is scheduled to be completed by the end of the year.

Mr. Corpuz announced that the sidewalk, which was the subject of a claim that was discussed at the study session earlier this afternoon, has been repaired.

Mr. Corpuz requested a permanent residency waiver to fill the position of System Protection Engineer at Tacoma Public Utilities.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Council Member Baarsma moved to authorize the City Manager to grant a permanent residency waiver to fill the position of System Protection Engineer located at Public Utilities. Seconded by Council Member Kirby.

Roll call vote was requested and taken, resulting as follows:

Ayes: 7 – Baarsma, Crowley, Kirby, McGavick, Miller, Phelps and Mayor Ebersole

Nays: 2 – De Forrest and Silas

The motion was declared adopted.

Deputy Mayor Crowley moved that the City of Tacoma accept the settlement of \$40,957.11 negotiated by the Legal Department in the matter of the claim of Kay Hoke, Claim No. 7753. Seconded by Council Member De Forrest. Voice vote was taken and carried. The motion was declared adopted.

Council Member Miller requested a follow-up on the appeal hearing that was held relative to the vacation of property on 38th and Washington Streets. He stated that it has become apparent over the years that the City of Tacoma's rights-of-way are more valuable to use for more than just vehicles. He stated that over the last decade the City of Tacoma has invested a lot of money in nonmotorized traffic circulation - pedestrian access and bicycle access. He requested that a policy be developed for the preservation of circulation corridors, for pedestrians, that effects the disposition of City rights-of-way. He stated that his concern is that this issue needs to be looked at in the bigger picture. Council Member Miller stated that the City of Tacoma needs to preserve those rights-of-way, or at least a portion of them, for pedestrian access or nonmotorized vehicular access. He stated that he has requested that the City Attorney rule regarding the City's legal rights to retain those rights-of-way.

Council Member McGavick reported that while she was recuperating from surgery she was driven around the City of Tacoma looking at sites for a new police station. She then stated that her mother had another stroke and had passed away.

Council Member Silas noted the passing of Ms. Louise Turner. She stated that there was a celebration of her life last Saturday. She commented on the wonderful life she had lived.

Council Member Silas then wished Mr. Bill Pugh a happy birthday.

Council Member De Forrest requested an explanation regarding the Police Department's budget. He stated that he wanted to know, in laymen's terms, why the Police Department has a \$3.3 million budget deficit and what the City of Tacoma is going to do to solve that deficit.

Council Member Baarsma stated that the City Council took action tonight on the settlement of a claim concerning an accident involving a hazardous sidewalk. He stated that right across the street from the Landmarks Convention Center is another sidewalk that is hazardous and should be investigated.

Council Member Baarsma stated that he had the opportunity to represent the Mayor at the second meeting of the Tri-County Endangered Species Act Response Assembly. He stated that the National Marine Fisheries Service is in the process of taking testimony to determine whether the Chinook salmon would be declared a threatened species. Council Member Baarsma stated that the assembly includes the County Executives of Pierce, King and Snohomish counties. He stated that representatives from major cities from each of those counties are also addressing the issue of how to respond proactively. He stated that the City has an opportunity, in concert with the State and Tribes, through the use of a threatened species declaration, to design a habitat conservation plan that is based on "rock solid science." He stated that the federal officials are quite pleased that the counties are meeting together.

Mayor Ebersole stated that he has been working with the Tacoma Housing Authority on many issues including Hillside Terrace.
