### **RESOLUTION NO. 30907**

### REQUESTED BY THE TACOMA CITY COUNCIL

A resolution condemning the advocacy of white supremacy.

WHEREAS this nation is grounded upon the self-evident truth that all men are created equal, and

WHEREAS the strength and vigor of our community are based upon principles of equal justice under law, equality of opportunity, and freedom from discrimination, and

WHEREAS, in recent weeks, certain individuals identified as members of the "Aryan Nation," a so-called "white supremacy" organization, were arrested on charges that they sought to perpetrate violent crimes against members of the minority communities of Tacoma and of our neighboring cities, and

WHEREAS the concept of crimes of violence against individuals on the basis of their status as a member of a particular racial, ethnic, religious, or sexual group is not only heinous and despicable, but violates the basic, fundamental political and moral values upon which our country was founded, and

WHEREAS the City Council has expressed the community's dedication and commitment to the values of its citizens by declaring as a misdemeanor the malicious harassment of any person because of that person's race, color, religion, ancestry, or national origin; and it is the intent of the City Council to reaffirm the community's dedication and commitment to the values of equality and freedom from threats or insecurity due to the status of any individual as a member of a particular race, religion, life-style, or personal convictions; Now, Therefore,

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TACOMA:

That the City Council does hereby reject and condemn the bigotry and violence advocated by the "Aryan Nation" organization;

BE IT FURTHER RESOLVED:

That the Tacoma Human Rights Commission, with or without outside resources, should expeditiously, and not later than June 22, 1990, recommend legislative, educational, and/or institutional actions that this community might take to strengthen our commitment to the freedom, equality, and security of our citizens;

BE IT FURTHER RESOLVED:

That the City of Tacoma calls on all citizens to join together in denying to any hate group any opportunity to engage in violent racism, and to decry and condemn the advocacy of bigotry and hate.

# COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL:

Mayor Vialle and Council Member Moss requested that the City Manager review the possibility of extending the land use notification requirements to a 1,000-foot radius, requiring the erection of signs on areas for land use changes, and reducing the density allowed within certain residential areas.

Council Member Nielsen stated that this could be included on the June 26 study session with the Council.

Mayor Vialle requested that Council be provided with a copy of Seattle's legislation on this particular matter.

Council Member Warnick discussed the problems of possible decline of the quality of education in Tacoma and asked that the staff bring a program to the Council of combining legislators and educators to discuss this problem.

Council Member Miller seconded Council Member Warnick's concerns regarding the potential decline of education in Tacoma, especially in the area of music and arts.

Discussion followed regarding education costs, quality, and problems in Tacoma.

Deputy Mayor Stenger stated that there may be an opportunity for further discussion of this matter on the Pierce County Action Agenda. He stated that the School District staff and board should be included in any future discussions. He also noted that Tacoma has been seriously restricted in funding levels, as a result of the state levy lid.

Council Member Warnick noted that the PLU women's softball team had taken second place in the national women's softball tournament.

Council Member Warnick stated that the Tacoma Tigers were still number one in their league. He also commented on the coverage in the News Tribune of the Tacoma Tigers team.

Mayor Vialle moved to recess to Executive Session to discuss litigation and property acquisition. The session not to exceed 40 minutes. Seconded by Council Member Evans. Voice vote was taken and carried. The motion was declared adopted.

Council recessed to Executive Session at 8:03 p.m. and reconvened at 8:43 p.m.
