City Council Chambers November 28, 1995

Council Member Miller moved that the Consent Agenda be approved. Seconded by Council Member Baarsma. Voice vote was taken and carried. The Consent Agenda was declared approved.

REGULAR AGENDA

FINAL READING OF ORDINANCES:

Council Member Kirby moved to suspend the rules to reconsider Resolution No. 33219. Seconded by Council Member Miller. Voice vote was taken and carried. The motion was declared adopted.

Resolution No. 33219

Authorizing the execution of an interlocal agreement with Pierce County regarding the site of a temporary jail facility to be located in the County-City Building parking lot and further expressing the support of Pierce County's effort to secure financing for a permanent jail facility.

Council Member Kirby moved to reconsider Resolution No. 33219. Seconded by Council Member Miller. Voice vote was taken and carried with Council Member De Forrest voting in opposition. The motion was declared adopted.

Council Member Silas moved to amend the interlocal agreement for Resolution No. 33219 by adding the following sections:

- "3.8 The County agrees to immediately establish a Citizen Advisory
 Committee on Corrections to look for creative alternatives to incarceration for
 certain misdemeanor offenses, and to expand and support the current effective
 correction programs and services that are working. The Committee should
 consist of at least seven, but no more than eleven, residents from the Third and
 First Councilmanic Districts of the City of Tacoma as recommended by the
 Tacoma City Council. It is further agreed that the County will provide the
 necessary staff support and other resources as needed to facilitate the work of
 the Advisory Committee.
- 3.9 The County agrees to set Minority and Women's Business Enterprise goals of 14% for Minority Business Enterprises and 8% for Women's Business Enterprises on the permanent jail facility constructed by the County.
- 3.10 The County agrees to establish a local employment program similar to the program adopted by the City of Tacoma to ensure that qualified and available residents from the City of Tacoma's Empowerment/Enterprise Zones are hired

and receive apprenticeship training as part of any and all constructed correction facilities authorized by the County.

To facilitate the participation of the City of Tacoma's Zone residents in Joint Apprenticeship and Training Council approved apprenticeship programs offered by Bates Technical College, the County agrees to establish an apprenticeship scholarship fund to pay the tuition cost of those residents who qualify for education assistance. The Citizen Advisory Committee on Corrections will provide advice, assistance, and oversight for the scholarship program.

Seconded by Council Member De Forrest.

Council Member De Forrest moved a friendly amendment to the proposed amendments to the interlocal agreement for Resolution No. 33219 by changing the Councilmanic District identified in Section 3.8 as follows:

"...residents from the Third and First-Second Councilmanic Districts of the City of Tacoma...

and insert this language following 6.81.090 F. as a new section 6.81.090 G. Seconded by Council Member Kirby. Council Member Miller withdrew his motion.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL:

Council Member Miller moved to excuse the absence of Council Member McGavick. Seconded by Council Member Silas. Voice vote was taken and carried. The motion was declared adopted.

Council Member Miller extended his thanks to his colleagues and staff for all of the heart felt condolences expressed over the past week. Council Member Miller commented that citizens concerned regarding public safety issues might like to attend the next Council meeting in support of the jail issues.

Deputy Mayor Evans reported on the signing ceremony for the interlocal agreement with the City of Federal Way and its Sister City Hachinohe, Japan. Deputy Mayor Evans also expressed concern regarding the increase in graffiti, particularly in the North End of Tacoma. He requested that the Police Department give that issue special attention. Deputy Mayor Evans asked staff to look into making it illegal to sell spray cans to anyone under the age of 18.

Council Member Baarsma concurred with the positive comments made by Deputy Mayor Evans regarding the signing ceremony with Hachinohe, Japan. Council Member Baarsma also expressed his concern regarding the decision by TCI to remove Channel 6, a Canadian broadcasting channel, from its programming.

Council Member Kirby asked the City Manager to look into what other jurisdictions are doing to address the issue of graffiti by dealing with point of sale purchases.

On proper motion, the meeting was adjourned at 12:04 a.m., November 29, 1995.
