Councilwoman Bichsel moved to amend the Resolution by changing the last paragraph to read as follows: "All ordinances, excepting those relating to Local Improvement Districts or pertaining to matters heard before the Hearings Examiner, shall appear on the Council Agenda for three weeks. All resolutions, excepting those relating to purchases, setting dates for hearing, Local Improvement Districts, or pertaining to matters heard before the Hearings Examiner, shall appear on the Council Agenda for two weeks. Initially, all ordinances and resolutions shall be

introduced and appear as part of the Consent Agenda, PROVIDED, that approval of said Consent Agenda shall not in any manner be deemed to constitute any action on such ordinances or resolutions. At the next succeeding reading, there shall be Council and public discussion thereon. At the third and final reading of ordinances, the Council may discuss such ordinances, but no public discussion shall be allowed, except as may otherwise be provided in these rules, and a final vote shall be taken thereon." Seconded by Mayor Parker. Voice vote was taken and carried.

Voice vote was taken on the Resolution as amended and carried. The Resolution as amended was declared adopted.

Mayor Parker moved to suspend the rules to consider Resolution No. 25227. Seconded by Councilman Nielsen. Voice vote was taken and carried.

Establishing the policy of limiting individual appointments to Committees.

Councilman Bichsel moved that the Resolution be adopted. Seconded by Councilman Kirby.

Councilman Evans moved to amend the Resolution on Line 15, to change the word financing to the word "funds." Seconded by Councilman Strege. Voice vote was taken and carried.

Councilman Evans moved to amend the Resolution on Line 14, after the word employee, add the words "or member of a Board of Directors." Seconded by Councilwoman Bichsel. Voice vote was taken and carried.

Councilman Evans moved to add a new paragraph as follows: "That, no individual at any time shall be a member of more than one committee appointed by the Council and/or the Mayor." He also moved to strike the first paragraph of the Resolution. Seconded by Councilman Kirby. Voice vote was taken and carried.

Voice vote was taken on the amended resolution and carried. The Resolution as amended was declared adopted.

PUBLIC HEARINGS AND APPEALS:

a. This is the date set for hearing the appeal for Parker Paint Manufacturing Company, Inc. on the Tax and License Department's Business and Occupation tax audit assessment.

Mayor Parker advised that the City has received notice that the appeal has been withdrawn.

Councilwoman Bichsel moved to remove the item from the agenda. Seconded by Councilman Nielsen. Voice vote was taken and carried.

b. This is the date set for hearing the appeal of C. W. Kinsman on the Hearings Examiner's recommendation to approve the Shoreline Management Permit Application No. 141.177 of the City of Tacoma to extend an 8-inch sanitary sewer and water main located on 6th Avenue from Seashore Drive to Wilton Road; Wilton Road from 6th Avenue to 600 feet south of 6th Avenue.

Mayor Parker advised that the City has received notice that the appeal has been withdrawn.

Mayor Parker moved that the item be removed from the agenda. Seconded by Councilwoman Bichsel. Voice vote was taken and carried.

c. This is the date set for hearing the appeal of The People of Peace Assembly on the Hearings Examiner's decision to deny a Special Use Permit for a private shoool in an "R-2" District for grades Kindergarten through Twelve, located at the southeast corner of North 24th and Warner Streets.

Bob Backstein, Hearings Examiner, reviewed the request for Council and his reasons for denying the Special Use Permit.

Reverend Joseph Miriella, Pastor of the Peace Assembly reviewed the church's plans for the proposed school at the church site and replied to concerns expressed by the neighborhood. He asked that the Special Use Permit be granted.

Councilman Nielsen moved to concur in the Findings, Conclusions and Recommendations of the Hearings Examiner and to deny the appeal. Seconded by Councilwoman Bichsel. Voice vote was taken and carried.

Councilman Nielsen moved to recess into Executive Session for the purpose of discussing a personnel matter. Seconded by Councilwoman Bichsel. Voice vote was taken and carried. The Council recessed at 7:55 P.M. The Council reconvened at 8:15 P.M.

REPORTS BY CITY MANAGER:

City Manager Erling Mork advised that Monday, August 28th at 5:30 p.m. there will be a follow-up budget study session at the Bicentennial Pavilion. Also, on Friday, August 25th at 11:00 a.m. there will be the dedication of the People's Center at 16th & K Streets and Friday, between 10:00 a.m. and 2:00 p.m. Senior Citizens Awareness Day will be held at the Bicentennial Pavilion.

COMMENTS AND COMMITTEE REPORTS BY MEMBERS OF THE CITY COUNCIL:

Councilman Strege commented on the Growth Policy Report and referred to the Pierce County Commissioners Resolution No. 20942 expressing their desire to cooperate with the City with the possibility of consolidating housing activities. He suggested a team to work with the Board of Pierce County Commissioners. Councilman Strege moved the appointment of a committee of three members of the City Council to communicate and investigate the feasibility of consolidating housing activities with Pierce County and report back to the City Council. Seconded by Councilman Evans. Voice vote was taken and carried. Mayor Parker appointed Council members Strege, Bichsel and Evans to the committee with Councilman Strege acting as Chairman.

Councilman Nielsen referred to the Political Sign Ordinance and said it ought to be enforced. Councilman Nielsen moved that any illegally posted signs collected by the Public Works crews will be destroyed subject to approval of the City Attorney. Seconded by Councilman Evans. Voice vote was taken and carried.

Mayor Parker commented that he had seen signs commerating Mao Tse-Tung's Memorial, from the Labor Party, posted illegally on signal lights. He asked the City Attorney to advise if we can adopt an ordinance to make them pay for the removal of those signs.

Mayor Parker advised that since Mr. Bob Backstein had resigned from City employment he is appointing Gary Sullivan, the City's Hearings Examiner, to the Tacoma Human Relations Hearings Tribunals on the cases of the P & B Services, Hygrade Meat Products and the Pink Garter. He said the confirming resolution would be on next week's agenda.

On proper motion, the meeting adjourned at 8:25 P.M.
