Councilman Strege asked if the art work for the Pavilion is in storage and could it be put into use someplace else.

Deputy Mayor Nielsen asked staff to investigate the delinquent in-lieu-of-taxes of the Tacoma Housing Authority and the possibility of charging interest.

Councilmen Hyde and Sutherland requested that a Study Session with the Housing Authority be scheduled within two or three weeks, to discuss the problem.
