Gary Sullivan, Hearings Examiner, reviewed his Findings, Conclusions and Recommendations.

John Graham, nor his representative, appeared at the hearing to speak.

Councilman Nielsen moved to concur in the Findings, Conclusions and Recommendations of the Hearings Examiner and deny the appeal. Seconded by Councilwoman Bichsel. Voice vote was taken and carried.

Councilman Evans suggested a review of the zoning along North "I" Street between North 2nd and Alder as part of the North Slope study.

Councilman Hudson suggested that the Landmarks Preservation Commission investigate the comments made at the Hearings Examiner's hearing regarding the deterioration of the Rust Mansion and to look at the range of alternatives for the future of the building.
