Creating and establishing a new fund, to be designated as the "Waterway Trust Fund," to receive payments from parties participating in the remedial design and remedial action work and payments from others settling their liability in the Thea Foss and Wheeler-Osgood Waterways; appropriating \$20,000,000 from said fund; amending the 2001-2002 Biennial Budget for remedial design and action work in said waterways; and declaring an emergency making necessary the passage of this ordinance and its taking effect immediately upon publication.

REPORTS BY CITY MANAGER

City Manager Ray E. Corpuz, Jr. gave an overview of the 2003-2004 Preliminary Budget that he and Diane Supler, Director of the Office of Budget, Management, and Analysis, presented at today's study session. He stated there would be a public hearing on November 5, 2002.

Mr. Corpuz requested an Executive Session to discuss pending litigation, not to exceed 20 minutes.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Council Member Lonergan thanked the City Manager and staff for addressing the public's concern to preserve direct services such as police, fire, libraries, streets, and parks relative to the budget; and that he hoped the City would be able to restore some of the funding back to the parks. He stated he would be willing to forego his cost-of-living increase if that would help to reduce employee layoffs. He challenged organized labor and the general public to become a part of the budget process. He then appealed to the public to think about volunteering in their communities.

Council Member Lonergan congratulated Police Officer Pat Franz, of Sector 4, who was named police officer of the year for the state of Washington by the Washington State Grange.

Mayor Baarsma announced that Pierce County Auditor Cathy Pearsall-Stipek, National President of the Organization of Elected Officials, is in Washington D.C. today with the President of the United States for the signing of the Voter Reform Act.

Mayor Baarsma commended the police and fire chiefs and staff for their efforts in assisting federal officials in conducting an investigation of the property at 3310 South Proctor to secure evidence relative to the sniper shootings. He also congratulated the people of that neighborhood for working with officials and sharing information regarding that property.

Council Member Miller moved to excuse Deputy Mayor McGavick from tonight's meeting. Seconded by Council Member Ladenburg. Voice vote was taken and carried. The motion was declared adopted.

Council Member Miller moved to convene to Executive Session to discuss pending litigation, the session not to exceed 20 minutes. Seconded by Council Member Moss. Voice vote was taken and carried. The motion was declared adopted.

Council convened to Executive Session at 6:20 p.m. Mayor Baarsma returned to the Council Chambers at 6:40 p.m. to extend the session an additional five minutes. Mayor Baarsma returned to the Council Chambers at 6:45 p.m. to extend the session another five minutes. The Council reconvened at 6:50 p.m.

Council Member Miller moved to authorize the City's full and final settlement in the case of Marcellino and Dora Trujillo v. City of Tacoma, et al., United States District Court Cause No. C01-5483, for the amount of \$330,000. Seconded by Council Member Moss. Voice vote was taken and carried with Council Members Ladenburg and Talbert voting in opposition. The motion was declared adopted.
