Police Chief Lyle Smith, in his last appearance before the Council prior to retirement, gave a lengthy report before the Council regarding the Police Department's statistica, goals, objectives and accomplishments during the past year. He also distributed a planning and summary booklet for 1976.

At the conclusion of his presentation, Mayor Johnston, speaking for the Council, commended Chief Smith for his years of service to the City and stated that he considers Smith one of the nation's best Police Chiefs.

Mr. Sonntag made a motion to excuse Mayor Johnston from next week's meeting. Seconded by Mr. Strege. Voice vote was taken and carried.

Mr. Strege made a motion to suspend the rules to hear a citizen speak. Seconded by Mayor Johnston. Voice vote was taken and carried.

Mr. Bill Buell, No. 32 California, approached Council and requested that something be done to reinstate the proposed Fourth of July Parade that apparently has been cancelled by the Bicentennial Committee.

Mr. Schroeder said he would check into the matter.

Mayor Johnston made a motion to recess into executive session for the purpose of discussing a proposed out-of-court settlement. Seconded by Mr. Nielsen. Voice vote was taken and carried. The meeting recessed at approximately 7 p.m.

Mayor Johnston reconvened the meeting at 7:16 p.m. whereupon Mr. Sonntag made the following motion: "I move that the tentative settlement of Ruth Myles vs. City of Tacoma et al, negotiated between the attorneys for Mrs. Ruth Myles and the City and as recommended by the City Manager in prior memos, be and the same is hereby approved and that the office of the City Attorney be authorized and directed to consent to the entry of a judgment or decree in the pending litigation, all in accordance with the terms of said proposed settlement Seconded by Mr. Hudson. Voice vote was taken and carried.
