Ordinance No. 27257

Amending Chapter 13.06 of the Municipal Code to reclassify the property located at 5402 Tacoma Mall Boulevard from an "R-2" One-Family Dwelling District to a "C-1" General Neighborhood Commercial District to allow for the operation of a beauty salon. (Clyde and Sukie Maxwell; File No. 40000023604)

FIRST READING OF ORDINANCES

Ordinance No. 27259

Amending Chapter 1.12 of the Municipal Code, relating to the Compensation Plan, to implement rates of pay and compensation for employees represented under the International Brotherhood of Electrical Workers, Local 483, Water Pollution Control Unit contract, which covers approximately 44 employees, effective January 1, 2004, to December 31, 2006; and changes in classification to reflect the organizational structure.

RESOLUTIONS

Resolution No. 36269

Authorizing the execution of an Interlocal Agreement with the Port of Tacoma to affirm the terms, conditions, and responsibilities for maintaining emergency and evacuation access through the Pierce County Terminal following the proposed Alexander Avenue street vacation.

Deputy Mayor Evans moved that the Resolution be adopted. Seconded by Council Member Phelps. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 36270

Authorizing the execution of an Interlocal Agreement with the Port of Tacoma establishing the Port's responsibilities with respect to City utility facilities within the right-of-way of the proposed Alexander Avenue street vacation.

Deputy Mayor Evans moved that the Resolution be adopted. Seconded by Council Member Phelps. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 36271

Authorizing the execution of an Interlocal Agreement with the Port of Tacoma to affirm the terms, conditions, and responsibilities relating to the full rehabilitation of the Hylebos Bridge, which will be repaired and reopened no later than January 1, 2007.

Deputy Mayor Evans moved that the Resolution be adopted. Seconded by Council Member Phelps. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 36272

Authorizing the execution of an Interlocal Agreement with the Port of Tacoma to affirm the terms, conditions, and responsibilities relating to the appropriate installation of traffic improvements necessary to reroute traffic from Alexander Avenue to Taylor Way and the storm and sanitary sewer issues relating to the proposed Alexander Avenue street vacation.

Deputy Mayor Evans moved that the Resolution be adopted. Seconded by Council Member Phelps. Voice vote was taken and carried. The Resolution was declared adopted.



Resolution No. 36273

Amending the *Rules of Procedure of the Council of the City of Tacoma* to change the order of business by moving the consideration of interlocal agreements to the Consent Agenda.
