a. Hearing Examiner submitting Shoreline Management Substantial Development Permit No. 141.544 to allow the environmental remediation of a former log sort yard located at 1602 Marine View Drive. (Port of Tacoma; File No. 141.544)

Ordinance No. 25335

Amending Title 1 of the Official Code relative to the Finance Department to be consistent with the implementation of Proposition No. 3.

The Ordinance was set over for final reading next week.

RESOLUTIONS:

Resolution No. 32207

Authorizing the execution of an agreement with the Tacoma-Pierce County Economic Development Board in the amount of \$60,000 for assisting the City with economic development activities.

Council Member Miller moved that the Resolution be adopted. Seconded by Council Member Nielsen. Voice vote was taken and carried. The Resolution was declared adopted.

Purchase Resolution No. 32263

Awarding contracts to:

- 1. Various laboratories, in the amount of \$100,000 to increase their contracts for various laboratory services Open Purchase Order No. 1982;
- 2. Northwest Cascade, Inc., in the amount of \$66,063.39 for storm drain repair located on East 18th and Dock Street Emergency Purchase Order No. 43257;
- 3. Square Deal Construction, on their bid of \$50,125 for Citywide sidewalk construction Specification No. G-229-93; and

Council Member Evans also requested staff to provide a report on what changes, if any, are being made by the Police Department on traffic enforcement and patrol in Northeast Tacoma.

Voice vote was taken and carried. The motion was declared adopted. Council recessed to Executive Session at 7:45 p.m. and reconvened at 8:10 p.m. At 8:10 p.m. Mayor Vialle announced that Executive Session would be extended an additional 10 minutes. Council reconvened at 8:20 p.m.
