Council Member McElliott reported on a very successful event of the Chinook Marina grand opening, which was held on Sunday, May 2, 1993.

Council Member Silas reported on the youth rap session that was held in the Hilltop last Monday. She indicated that the number one concern was year-round job opportunities and employment. The second most important concern was gangs and the third was to have a youth TV program. Council Member Silas indicated efforts are being made to form a youth committee.

Council Member Miller commended staff for its participation in the recycling program.

Council Member Evans stated that there was not enough news coverage on the event itself of the Chinook Marina grand opening.

Council Member Evans reported that the Older American event he attended as the City's representative was well attended.

Council Member Miller moved to excuse the absences of Mayor Vialle and Council Members Nielsen and Moss. Seconded by Council Member Evans. Voice vote was taken and carried. The motion was declared adopted.
