Ordinance No. 22816

Amending Chapter 6.29 of the Official Code to provide a licensing category to cover fully commissioned police officers when engaged in business in an "off-duty" capacity.

Councilman Ladenburg moved to amend Ordinance No. 22816 on page 5 line 10 to change the license fee for a Commissioned Police Officer from \$25 to \$5. Seconded by Councilman Hyde. Voice vote was taken and carried.

The Ordinance, as amended, was set over for final reading next week.
