Amending Chapter 13.06 of the Municipal Code to reclassify 13 parcels of property from an "R-2 SRD" Residential Special Review District and 3 parcels of property from an "R-3" Two-Family Dwelling District to a "C-2" General Community Commercial District, located west of A Street between South 38<sup>th</sup> and South 37<sup>th</sup> Streets, to allow construction of a 44,649-square-foot Albertsons grocery store, a 6,250-square-foot retail commercial building, and off-street parking. (Pacific Land Design; File No. REZ2002-00002)

# COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Council Member Talbert encouraged everyone to drive by lower McKinley Avenue to view an impressive art project painted on three separate properties by 16 artists from the Pacific Gallery Artists. He stated the project came about through a \$4,000 Innovative Grant from the Eastside Neighborhood Council.

Deputy Mayor McGavick stated there have been remarks that the Council will be closing the Kobetich Branch of the Library. She stated she is unaware of any such cut and that the Council does not make those decisions. She stated the Council's responsibility is to pass a budget.

Mayor Baarsma invited the public to attend the Library Board public hearing tomorrow night, at 5 p.m., at the Main Library. He stated they will be discussing library models and budget proposals and that he would present up-to-date information relative to the budget process. He stated no final decisions have been made.

Council Member Miller stated as a member of the Association of Washington Cities where he serves on the Legislative Committee and chairs the Subcommittee on Energy, Telecommunications, Environment and Land use, he attended a meeting to address issues regarding resolutions for the upcoming Legislative session. He stated they addressed the International Building Code, which the State has not updated since 1997, and could affect insurance rates; annexation reform; and land use regulations.

Mayor Baarsma stated he and Randy Lewis, Government Relations, met with the mayors of Seattle, Spokane, Vancouver, Yakima, and Bellingham to present a united front to the Legislature relative to the formation of street utilities, expanding the Tax Increment Financing Strategies, and a county-wide utility tax. He stated they also looked at how these relate to the Health Department, which has been impacted by Initiative 695, and that now is not the time to make cuts in the Health Department.
