Resolution No. 35240

Setting Monday, August 27, 2001, at 5:00 p.m., as the date for a hearing by the Hearing Examiner, on LID No. 8632, for the placement of permanent pavement in the alleys between Asotin and Alaska Streets, from South 74th Street north 305 feet, and between Cedar and Alder Streets, from South 56th to South 58th Streets.

Resolution No. 35245

Authorizing the execution of an agreement with the Metropolitan Development Council, in the amount of \$104,000, to operate the Emergency Major Home Repair program in accordance with the 27th Year Community Development Block Grant program.

Council Member McGavick moved that the Resolution be adopted. Seconded by Council Member Dahl. Voice vote was taken and carried, with Council Member Davis recusing herself. The Resolution was declared adopted.

Resolution No. 35246

Authorizing the execution of a consultant agreement with CES Consulting Engineers, in the amount of \$62,521, to prepare plans and specifications for seismic retrofit of the Yakima Avenue Bridge and the Union Avenue Viaduct.

Council Member McGavick moved that the Resolution be adopted. Seconded by Council Member Miller. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 35247

Authorizing the payment of up to \$120,000 to the Union Pacific Railroad for rail car interchange with the Tacoma Rail Mountain Division pursuant to the existing interchange agreement.

Council Member McGavick moved that the Resolution be adopted. Seconded by Council Member Miller. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 35248

Authorizing the execution of a letter of intent to sell real property located between Center and South 34th Streets, on Tyler Street, to the Tacoma-Pierce County Habitat for Humanity and the Tacoma Rescue Mission for the construction of affordable housing.
