PUBLIC HEARINGS AND APPEALS: (Began at approximately 6:55 p.m.)

a. Paul Meneghel appealing the decision of the Hearing Examiner to reclassify a 16-acre area bounded by Cheyenne Street on the east, South 18th Street extended on the south, Gove Street on the west and South 12th Street on the north, from a "R-2" One-Family Dwelling District to a "R-2PRD" Planned Residential Development District for the development of single-family homes and duplex units on a 30-lot and 25-lot subdivision. Council Member Miller moved to remand the decision of the Hearing Examiner Pro Tem for the purpose of taking testimony on a preliminary plat map which shall include lot-like dimensions and evidence that the lot dimensions do not intrude on the required wetlands buffer identified by the Hearing Examiner Pro Tem. Seconded by Deputy Mayor Evans. Voice vote was taken and carried. The motion was declared adopted.

b. <u>Nineteenth Street Coalition for Neighborhood Preservation</u> appealing the decision of the Hearing Examiner to reclassify the property located at the northwest corner of South 19th Street and Sprague Avenue from a "R-2" One-Family Dwelling District to a "R-2T" Residential Commercial Transitional District for a proposed medical office building. (MacLiam Properties; File No. 120.1364)

Council Member Miller moved that the request for dismissal of the appeal be granted and the appeal fee refunded to the appellant. Seconded by Deputy Mayor Evans. Voice vote was taken and carried with Council Members De Forrest and Silas voting in opposition. The motion was declared adopted.

City Manager Ray E. Corpuz, Jr. announced that he and the Director of Public Utilities have appointed Elvin Vandeberg to the Civil Service Board through February 1996.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL:

Deputy Mayor Evans reported that the Maritime Fest will be held on September 22-24, 1995. He added that the City will be involved with the lighting of the 11th Street Bridge which will take place on September 23, 1995 at 8:00 p.m. He encouraged everyone to attend.

Council Member McGavick welcomed Council Member Crowley back.

Council Member Silas expressed concerns about the manner in which the DeLong Lake appeal was handled. She commented that the citizens in the audience had been waiting since 5:30 p.m. and the appeal wasn't considered until almost 7:00 p.m. She explained that when the item was heard, the citizens didn't seem to have an understanding of the action Council took. She requested that staff elaborate and clarify to the appellant Council's motion on the appeal.

Council Member Baarsma reported on the Public Sector Network workshop sponsored by the American Society for Quality Control that he attended this past weekend.

Council Member Kirby also commented on the citizensⁱ reaction on the DeLong Lake appeal. Council Member Kirby requested that he be provided with another copy of the storm sewer utility report that was sent to him after the Council study session presentation on this matter.

Council Member De Forrest commented on a meeting he and Mayor Moss attended at the Salishan community on a beautification project. Council Member De Forrest asked the City Manager to check if the sewer lines to about a half dozen to a dozen Tacoma Housing Authority homes that are currently jacked up for new foundations were capped. Council Member De Forrest wished Mayor Moss and the City Manager a safe trip.

Mayor Moss commented on a request from Intel about the construction of the interchange on I-5 and their timeframe for operating their business. Mayor Moss thanked the Mayor of DuPont and Pierce County for working together to streamline the construction of this project from 15 months to 12 months.

Mayor Moss announced that the September 19, 1995 City Council meeting will be held at 4:00 p.m. instead of 5:00 p.m. in the City Council Chambers.

Council Member De Forrest indicated that he objected to meeting at 4:00 p.m. because he would not be able to attend at 4:00 p.m. He also indicated that the Open Meetings Act allows the City Council to set a regular time and place to hold Council meetings. At any other time, it becomes a special meeting and the Act requires one item on the agenda.

Council Member Miller moved that the Council hold a special meeting of the Council on September 19, 1995, at 4:00 p.m., in the Council Chambers for the purpose of convening to Executive Session to discuss potential litigation, and that the regular meeting of the City Council be held at 5:00 p.m. Seconded by Council Member McGavick. Voice vote was taken and carried. The motion was declared adopted.
