## **REPORTS BY CITY MANAGER**

City Manager Ray E. Corpuz, Jr. presented the 2001-2002 City of Tacoma Preliminary Biennial Budget.

Mr. Corpuz stated that at the study session today details and an overview of the Preliminary Biennial Budget were presented. He stated that the presentation tonight is the official presentation of the budget, which will consist of overview and key issues of that budget and recommended future direction.

Key Features:

- Copies available to public through the Budget Office or City Clerk's Office
- No growth budget of the General Fund and General Fund supported services
- Modest growth of services for Utility Enterprise funds
- Overall a lean budget
- Proposal represents about \$1,753,273,490 in services to Tacoma citizens and Utility customers
- Includes General Fund at \$305,119,000 (represents about 18% of total budget)
- Total General Government, Utility Enterprise Funds, total about \$301,885,000 and the Public Utility Department represents about \$748,655,000, of which \$612,000,000 is for the Power and Light fund.
- Other funds include: Trust and Agency funds; Intergovernmental funds; Capital Project funds; Debt Service funds; and Special Revenue funds totaling about \$398,615,000
- Follow assumptions and requirements to include support of the Strategic Plan priorities, establishment of program performance measures, and reduction in employer/employee shared pension contributions, which is 1.46 percent; General Fund departments to develop budget requests with a 2 percent overall reduction in their current appropriation based on the mid-biennium correction of the 1999-2000 biennium, which was reduced by \$6,000,000 of the base revenues and 56 full-time positions.
- In the 2001-2002 preliminary biennial budget approximately 11 full time positions will be lost
- Strategic focus areas; market-rate adjustments of 3 percent in 2001 and another in 2002 on average
- Medical premium increases equal 8.8 percent and 10 percent, respectively for 2001 and 2002
- Dental increases are zero in 2001 and 5 percent in 2002
- Assumes continuation of regular property tax levy of \$3.60 per \$1,000 of assessed valuation
- City Council must approve the property tax levy annually, would require six votes
- IPD equals 1.8 percent currently
- Continues reduction of business tax level; based on five-year plan and policy direction
- Projects conservative rate increases consistent with the five-year plans for Solid Waste Management, Wastewater Management Utility, and Surface Water Management Utility

- Increasing parking garage rates to increase parking capacity and fund additional parking construction; transfer the Streetlighting Program to the Department of Public Utilities in 2002
- Maintains current service levels for Police and Fire
- Provides sufficient funding for Metropolitan Parks to prevent any closures or significant program reductions
- Maintains current level of service at the Tacoma Public Library
- Requests an increase of \$500,000 in the Public Utility support for Economic Development for marketing efforts
- Provides for replacement of the Emergency Communication System at \$1.2 million and assumes the Law Enforcement Support Agency would use existing funds to implement the full project
- Continues to address the Endangered Species Act under the federal law
  Focuses on completing the identified priority capital projects, and for additional soft costs, acquisition and implementation of projects

Future Directions:

- Capital projects, constructing a new Greater Tacoma Convention Center; the Costco site complex for Police, Streets, and Fleet activities
- A fully developed systems approach for determining priorities and financing of capital projects
- Capital bond issue in 2001 that would address the capital needs of the Police Department facility with Streets, Maintenance and Fleet as part of that
- Improvements in infrastructure for the Neighborhood Council areas, improvements to the business districts, support of the expansion and renovation of the performing arts centers; and establishment of a new trust fund for affordable housing
- Review the existing building and facility needs to determine staffing requirements
- Review the 1997 interlocal agreement with the Metropolitan Park District to determine future funding support
- Complete the Police Department's performance audit and present a Resolution to the City Council establishing an independent audit committee; select an independent audit firm to conduct the first set of audits; the first will be the Police Department and in 2001, Finance and the Fire departments
- Consider raising rates, charges and fees if State Initiative 695 is found unconstitutional
- Pending voter approval of Initiative 722, the City will be challenged by a loss of at least \$9,000,000 to the General Fund along with effects to the Enterprise funds; recommend looking at that in April, and if Initiative 722 passes, taking a conservative approach to expenditures

- November 14 Public Hearing on the 2001-2001 preliminary biennial budget
- December 5 First Reading of Budget Ordinance
- December 12 Final Reading of Budget Ordinance and Ad Valorem Taxes

Mr. Corpuz thanked the City Council for their guidance and consultation as the budget was assembled. He thanked the employees for their quality of service. He thanked the stewardship of the Department Directors. Mr. Corpuz then gave a special thanks to Ms. Judith Shoudy, Director of Management, Budget and Analysis.

Mayor Ebersole then thanked City Manager Ray E. Corpuz, Jr. for his diligence, professionalism and wisdom.

Mr. Corpuz then extended best wishes for recovery to Harold LeMay, who suffered a heart problem and is in serious, but stable condition at St. Clare Hospital.

# COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Council Member Evans thanked the 60 volunteers, as members of Tacoma's Green Team, who planted 5,000 trees and small plantings at South 19<sup>th</sup> and Highway 16. He stated that he would write personal letters to each volunteer.
