The Resolution was set over for one week.

Authorizing the execution of an agreement with Pierce County Fire Protection District #2 for mutual fire protection assistance.

COMMENTS AND COMMITTEE REPORTS BY MEMBERS OF THE CITY COUNCIL:

Councilman Hyde asked for some information from the City Manager's staff with respect to areas within the City limits where there is discharge of untreated sewage.

Councilman Ladenburg stated that he has become aware of the fact that there is some public misunderstanding of the Charter Review Committee's purposes and objectives and made the following statement: "The Charter Review Committee, being aware that there is some public misunderstanding of both the Committee's purpose and objectives, hereby adopts the following statement: The Charter Review Committee is charged by the City Council with the review of the relationship of the City Council and the Utilities Department. The Committee shall investigate the historical development of the present charter language and shall develop several proposals for public discussion. The various proposals may include redirecting authority to the Utility Board, or to the City Council, and may include making no change at all. Further, proposals will be solicited from interested groups and citizens. All possible changes will be evaluated, discussed, and will be available for comment at public hearings. The Committee will present its findings to the City Council in the form of one or more alternatives."

Councilman Hawkins presented Deputy Mayor Nielsen with a country/western picture for his office because of the way he voted on a matter of public arts when it was determined that at a Summer Pops! Festival country/western music would be provided.
