REPORTS BY CITY MANAGER

City Manager Ray E. Corpuz Jr. introduced Carol Bellinger, General Services Department, Asset Management Division, as the next Special Assistant in the City Manager's Office until June 1998.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Council Member Miller reported that he and Council Member Baarsma had attended the launching of a boat, which was a product of the Sea Scout Explorer program. He stated the Sea Scout Explorer program, under the Pacific Peaks Council, is one of the largest programs in the nation and one of the most successful. Council Member Miller requested a study session to tour the Sea Scout Explorer base on the Foss Waterway. He stated that it is important for the Council to get a sense of what they are supporting and the benefits for the youth in the program.

Council Member Baarsma commented on some of the events he attended over the past weekend. He stated that he enjoyed watching the launch of the boat, the planting of the tree at Arbor Day, and the Junior Daffodil Parade. Council Member Baarsma then stated he watched a Sunday morning CBS news program which focuses on positive things relating to the arts, music, and authors. He stated that the glass program at Jason Lee Middle School was featured on the program. He then requested the City Manager get a copy of the program to be broadcast on Tacoma TV 12.

Council Member Silas commented on the positive effects of the Arbor Day Celebration on 8th and I Streets. She stated she had also watched the Sunday morning program and had great pride in our youth at Jason Lee Middle School in the glass blowing class. She also mentioned that the City of Tacoma should also be given credit for funding the program.

Council Member Phelps stated that he had gone to Olympia with Mayor Ebersole, Deputy City Manager Walton, and others from the community to sign our International Service Development Zone Bill. He stated that it was an initiative that many people had been working on for almost three years. He stated that the bill is the first leg of a major initiative for job creation in Tacoma. Council Member Phelps thanked Randy Lewis who headed up the initiative and worked extremely hard on it. He stated that today they had a meeting with United States Congressman Norm Dicks to discuss the next phase for the implementation of the initiative. He stated that Congressman Dicks was extremely complimentary of our efforts.

Council Member Kirby moved to excuse Mayor Ebersole from tonight's meeting. Seconded by Council Member McGavick. Voice vote was taken and carried. The motion was declared adopted.

Deputy Mayor Crowley stated that he had attended the Miss Wheelchair Washington Pageant, which was attended by at least 150 people at the LaQuinta Inn. He stated that this year's winner was Lisa Doolittle, who is from our area. He congratulated all of the contestants in the pageant. He stated that Elaine Stefanowicz is the reigning Miss Wheelchair America Queen. Deputy Mayor Crowley said that today he went to the opening of the Point Defiance Senior Center, which is now being run by the Franke Toby Jones Home. Deputy Mayor Crowley reminded everyone that the opening game of the Tacoma Rainiers will be held at Cheney Stadium this Saturday night. He also stated that he would be the keynote speaker for the American Public Works Association this year.
