FINAL READING OF ORDINANCES

Ordinance No. 26443

Approving the production of the Video Voters' Pamphlet; and adopting the Video Voters' Pamphlet Administration Rules & Regulations for the 1999 primary and general elections.

Council Member De Forrest moved to amend Exhibit A of Ordinance No. 26443, the Video Voters' Pamphlet Administration Rules & Regulations, page 3, to add a new Section 7.0, "PRODUCTION FEES," to read as follows:

7.0 PRODUCTION FEES:

7.1 A \$100.00 production fee will be assessed to each participating candidate to cover studio and editing time. Candidates who will appear on a General Election Ballot may choose to replay statements recorded for a Primary Election by paying a \$50.00 inclusion fee or may record a new statement in the TV Tacoma Studio for the full production fee of \$100.00.

Seconded by Council Member Baarsma. Voice vote was taken and carried. The motion was declared adopted.

Council Member De Forrest moved to amend Exhibit A to Ordinance No. 26443, the Video Voters Pamphlet Administration Rules & Regulations, page 3, to add a new Subsection 7.2 to Section 7.0, "PRODUCTION FEES," to read as follows:

7.0 PRODUCTION FEES:

7.2 A candidate lacking sufficient assets or income, and who has filed for office without paying a filing fee under RCW 29.15.050, shall not be required to pay a production fee.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Council Member Crowley moved to accept the settlement of \$58,500, negotiated by the Legal Department, in the matter of Rochelle Avery v. City of Tacoma, et al. Pierce County Superior Court Cause No. 97-2-06969-1. Seconded by Council Member Phelps. Voice vote was taken and carried. The motion was declared adopted.

Council Member Miller moved to excuse Council Member Silas from tonight's meeting. Seconded by Council Member McGavick. Voice vote was taken and carried. The motion was declared adopted.

Council Member Phelps encouraged the public to participate in a public hearing regarding the recommendations by the community relative to group care homes Class II zoning proposals on June 16, 1999, at 4:00 p.m., on the first floor, of the Tacoma Municipal Building, in the Council Chambers.

Council Member McGavick stated that the Arts Commission is busy preparing information for an upcoming study session.

Council Member Miller requested that a form be developed for the residential rental registration program for customers to fill out to register their property.

Council Member De Forrest requested that the Arts Commission and the Landmarks Preservation Commission not use the Tacoma Economic Development Department's letterhead for their minutes. He stated that both of these Commissions advise the City Council, but are not a part of the Tacoma Economic Development Department.

Council Member Baarsma stated that he attended the Environmental Commission meeting last evening in which a presentation was made by a fisheries biologist employed by the Puyallup Tribe. He stated that the presentation was about 13 fishery restoration areas that exist along the Puyallup River. He said the intent of each of these project areas is to increase the amount of available spawning and rearing habitat. Council Member Baarsma stated that although complete restoration of the Puyallup River is impossible he was amazed to find that there are at least 20 miles that could be restored. He stated that he would be discussing with staff the position the City of Tacoma might take regarding further exploration.

Deputy Mayor Kirby expressed his appreciation for the opportunity to represent the Mayor while he was gone.

Mayor Ebersole expressed his condolences regarding the passing of Mr. Kelso Gillenwater, former publisher of *The News Tribune*. He stated that he was a person who added a great deal to the civic life of our community and will be a tremendous loss for our City.



Council Member Crowley moved to convene to Executive Session to discuss labor negotiations, the session not to exceed 20 minutes. Seconded by Deputy Mayor Kirby. Voice vote was taken and carried. The motion was declared adopted.

The City Council convened to Executive Session at 6:14 p.m. and reconvened at 6:34 p.m.
