Council Member Crowley moved to authorize final settlement in the case of <u>Diana F. Stewart vs. City of Tacoma, Et Al.</u>, United States District Court No. C99-5069RJB, for the sum of \$75,000. Seconded by Deputy Mayor Kirby. Voice vote was taken and carried, with Council Member De Forrest voting in opposition. The motion was declared adopted.

Deputy Mayor Kirby requested that the City Council be assured that there will be a public process so that the citizens will have an opportunity to address the City Council regarding the closure of a fire station and how the City will provide fire service in Tacoma.

City Manager Corpuz stated that on Tuesday, November 16, 1999, at noon, a study session has been scheduled to discuss the proposed Biennial Budget Modifications with the City Council. He stated that at approximately 5:30 p.m., that same evening, during the City Council meeting, a public hearing on the proposed Biennial Budget Modifications has been scheduled. Mr. Corpuz stated that citizens are encouraged to testify and make their concerns and issues known at that time. He stated that there will also be an Ordinance before the City Council to implement any modifications, at which time citizens will be afforded another opportunity to testify on the proposed Biennial Budget Modifications.

Council Member Baarsma clarified the proposal that the City Council received from the City Manager which indicates one approach of dealing with the budgetary challenge the City is currently facing. He stated his understanding of that approach is across the board reductions in all the various categories.

City Manager Corpuz stated that he provided the City Council an initial approach involving the \$3.5 million problem the City has for the current Biennial Budget. He stated that it has been suggested in the past, that one way to look at reductions, so that everyone shares equally, would be to reduce the General Fund budget by the

appropriate amount that each department shares in the General Fund. He stated that this approach doesn't address the issue programmatically or operationally.

Council Member Phelps congratulated the City Manager and Mrs. Corpuz on the birth of their grandchild.
