Ordinance No. 27242

Amending the Municipal Code by repealing and reenacting Chapter 3.02, relating to the Fire Code, and adopting the 2003 Edition of the International Fire Code to be consistent with state law.

The Ordinance was set over for final reading next week.

Ordinance No. 27243

Amending Chapter 1.12 of the Municipal Code, relating to the Compensation Plan, to implement rates of pay and compensation for represented employees of the United Transportation Union, Switch Crews Unit, covering 46 employees; and the Brotherhood of Locomotive Engineers, covering 5 employees; and changes in classification to reflect the organizational structure.

The Ordinance was set over for final reading next week.

Ordinance No. 27244

Amending Chapter 8.109 of the Municipal Code, relating to public safety and curfew for minors, by designating the Metropolitan Development Council as an appropriate entity to take custody of minors from the Tacoma Police Department until the parent, guardian, custodian, or extended family member arrives to pick up the minor.

A. Mortenson Company, in the amount of \$2,863,587, for a cumulative total of \$66,056,587, to provide general contractor services for the Downtown Redevelopment Project.

Resolution No. 36191

Authorizing the execution of a Memorandum of Agreement between the Public Works Department and the Belt Line Division transferring operational control for the operation of the Tacoma Rail Mountain Division to the Belt Line Division for efficient and costeffective management of the railroad; to secure a Bridge Loan, in the amount of \$2.2 million, to fund Mountain Division rail operations through December 31, 2005; and further extending the existing interfund loan in the amount of \$2.5 million.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Council Member Anderson reported on the notification and public hearing for Tacoma Housing Authority relating to Section 8. She stated that the Tacoma Housing Authority is asking for stop gap funding to reduce the number of families who may lose their homes by this summer.

Council Member Talbert also commented on the concerns of the Tacoma Housing Authority. He mentioned the newspaper articles indicating an increase in violent crime on the East Side and commended City Manager James Walton and Police Chief Don Ramsdell for addressing these issues. He stated the Tacoma Police Department is making every effort to reduce violent crime. He also announced upcoming meetings to meet community needs relating to crime.

Council Member Ladenburg commented on the recent "Youth Explosion" event and announced that there were approximately 400 students in attendance. She quoted an article in *The News Tribune* from a student and asked the community to recognize and compliment young people in their efforts to succeed.
