Amending Chapter 1.90 of the Municipal Code, relating to the Local Employment and Apprenticeship Program (LEAP), by adjusting the LEAP Utilization Goal to consist of a 15 percent local resident and/or Pierce County apprentice hire requirement; creating a new sub-goal that targets Renewal Community (RC) residents; creating a new Target Area that encompasses RC residents plus residents in high unemployment census tracts; increasing penalties for contractors failing to meet the LEAP Utilization Goal; and declaring an effective date of August 1, 2005.

### Ordinance No. 27369

Amending Chapter 10.26 of the Municipal Code, relating to the historically underutilized business enterprises, by repealing and reenacting said Chapter; and directing the City Manager and the Director of Public Utilities to review the implementation of Chapter 10.26 and report their findings to the City Council every two years.

### Ordinance No. 27370

Amending Chapter 1.12 of the Municipal Code, relating to the Compensation Plan, to implement rates of pay and compensation for approximately 95 employees représented by the International Association of Machinists and Aerospace Workers, District Lodge 160, on behalf of Local Lodge 297, General Unit, effective January 1, 2004; and changes in classification to reflect the organizational structure.

The Ordinance was set over for final reading next week.

#### Ordinance No. 27371

Providing for the issuance of a Limited Tax General Obligation Line of Credit Note, 2005, in a principal amount not to exceed \$2,400,000; depositing in and appropriating said sum from the Tacoma Police Facilities Construction Fund to complete the Police Headquarters and substations; and amending the 2005-2006 Biennial Budget.
